#### TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, MARSHA DELL ANTHONY, State Bar Card No. 01271500 (hereinafter called "Respondent"), showing the Court:

#### I.

Pursuant to Rule 190.1, Texas Rules of Civil Procedure, discovery in this case is governed by Discovery Control Plan -- Level 2, as provided in Rule 190.3, T.R.C.P.

#### II.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, <u>et seq.</u> (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after March 15, 1999.

Disciplinary Petition -- CFLD v. Anthony Page 1 of 4 Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has her principal place of practice in Williamson County, Texas. Respondent is not represented by counsel herein. Service on Respondent is necessary at this time and should be served upon Respondent at her office at 506 Martin Luther King Blvd., Georgetown, Texas 78626.

#### IV.

Respondent was retained on or about November 28, 1998, by Ronnie J. Kirby (hereinafter called "Complainant") to represent Complainant in a divorce action. Complainant paid Respondent \$500.00 in attorney's fees for said representation. On or about December 23, 1998, Respondent was to appear at a hearing on behalf of Complainant. Respondent failed to appear. She made no effort to contact the Court or Respondent. In addition, Respondent failed to return Complainant's phone calls and to communicate the status of the case and of the settings of subsequent hearings. Therefore, Complainant was forced to hire another attorney to represent him. However, Respondent will not cooperate with the new attorney to transfer Complainant's file. This omission has further impeded the resolution of the divorce action.

#### V.

Such acts and omissions on the part of Respondent as are described in Paragraph IV hereinabove, constitute professional misconduct in violation of Rule 1.01(b)(1) [a lawyer shall not

Anthony Page 2 of 4 neglect a legal matter entrusted to the lawyer] and Rule 1.01(b)(2) [frequently fail to carry out completely the obligations that the lawyer owes to a client or clients] of the Texas Disciplinary Rules of Professional Conduct and Part 1.06(Q)(1) of the Texas Rules of Disciplinary Procedure.

#### VI.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of the Chief Disciplinary Counsel of the State Bar of Texas by Ronnie J. Kirby filing a complaint on or about March 15, 1999.

#### PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other and further relief to which entitled, including costs of court and attorneys fees.
