DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, TERRY E. STORK, State Bar Card No. 19323000 (hereinafter called "Respondent"), showing the Court as follows:

I.

Pursuant to Rule 190.1 of the Texas Rules of Civil Procedure, discovery in this case is governed by Discovery Control Plan -- Level 2, as provided in Rule 190.3 of the Texas Rules of Civil Procedure.

H.

Petitioner brings this disciplinary action pursuant to the State Bar Act, V.T.C.A.,

Government Code §81.001, et seq. (1998), the Texas Disciplinary Rules of Professional

Conduct, and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis

of the Disciplinary Petition was filed on or about April 21, 1998.

III.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Travis County, Texas. An officer may serve citation on Respondent at his office address located at 1705 S. Lamar Blvd., Austin, Travis County, Texas 78704.

IV.

On or about March 20, 1995, Lorilie C. Jackson (hereinafter called "Complainant") hired Respondent to represent her on an assault charge. Complainant agreed to pay Respondent a fee of \$750 for legal services associated with that charge. Respondent made the first appearance for Complainant in the assault case, and arranged for a cash deposit bond secured by \$200, with a principal sum of \$2,000. After that time, Respondent failed to attend scheduled hearings and failed to properly notify and inform Complainant of hearings which resulted in her bond forfeiture. On or about November 6, 1997, Complainant learned about the bond forfeiture only when she was arrested on the bond forfeiture and a subsequent burglary of a habitation charge. Respondent again agreed to be Complainant's attorney of record and handle the burglary of a habitation charge. Again, Respondent failed to attend scheduled hearings and failed to properly notify and inform Complainant of hearings.

In addition, on or around September of 1995, Complainant hired Respondent to negotiate Complainant's purchase of real estate. Despite receiving payment of \$250 and agreeing to negotiate the transaction, Respondent failed to pursue Complainant's civil real estate matter. When Complainant inquired as to the status of the negotiation, Respondent assured her that he had prepared the necessary paperwork and had mailed it to the seller. Despite those assurances, Complainant later learned that Respondent failed to pursue this real estate matter for which he was paid. Subsequently, citing the delay in the negotiations, the seller decided not to sell the land. Consequently, Complainant was forced to hire another attorney to resolve her legal disputes.

VI.

Such acts and omissions on the part of Respondent as are described in Paragraphs IV & V hereinabove, constitute the violations of the following Texas Disciplinary Rules of Professional Conduct for which he should be disciplined pursuant to Rule 3.09 of the Texas Rules of Disciplinary Procedure:

1.01(b)(1): In representing a client, a lawyer shall not:

(1) neglect a legal matter entrusted to the lawyer;

1.01(b)(2): In representing a client, a lawyer shall not:

(2) frequently fail to carry out completely the obligations that the lawyer owes to a client or clients.

1.03(a): A lawyer shall keep a client reasonably informed about the status of a matter and promptly comply with reasonable requests for information.

1.03(b): A lawyer shall explain a matter to the extent reasonably necessary to permit the client to make informed decisions regarding the representation.

VII.

The complaint which forms the basis of the cause of action hereinabove set forth in paragraphs IV and V was brought to the attention of the Office of the Chief Disciplinary Counsel of the State Bar of Texas by Lorilie C. Jackson filing a complaint on or about April 21, 1998.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant and that Petitioner have such other and further relief to which entitled, including costs of court and attorneys fees.
