**COMES NOW** Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, Donald W. Hill, (hereinafter called "Respondent"), showing the Court:

#### I.

#### **Discovery Control Plan**

Pursuant to Rules 190.1 and 190.2, TEXAS RULES OF CIVIL PROCEDURE (TRCP), Petitioner intends discovery in this case to be conducted under the Level II Discovery Control Plan.

#### II.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, <u>et seq.</u> (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

#### III.

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Dallas County, Texas.

On or about September 29, 1997, La Verne A. Bryan ("hereinafter referred to as Bryan") hired Respondent and paid him a retainer of \$5,000.00 to represent her in a wrongful termination matter. Thereafter, Respondent neglected Bryan's case in that he failed to inform Bryan that a Motion for Summary Judgment had been filed. Respondent also failed to file a response to the Motion for Summary Judgment.

#### V.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs IV, hereinabove, which occurred on or after January 1, 1990, constitute conduct which violates Rules 1.01(b)(1), 1.03(a) and 1.03(b) of the Texas Disciplinary Rules of Professional Conduct.

#### VI.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by La Verne A. Bryan filing a complaint on August 4, 1999.

#### <u>PRAYER</u>

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
