### **ORIGINAL DISCIPLINARY PETITION**

#### TO THE HONORABLE JUDGE OF THE COURT:

COMES NOW, Petitioner, the COMMISSION FOR LAWYER DISCIPLINE, a committee of the STATE BAR OF TEXAS (hereinafter referred to as "Petitioner"), complaining of Respondent, GEORGE M. HAMM (hereinafter referred to as "Respondent"), and would respectfully show unto the Court the following:

#### I. DISCOVERY CONTROL PLAN

Pursuant to Rules 190.1 and 190.2, TEXAS RULES OF CIVIL PROCEDURE (TRCP), Petitioner intends discovery in this case to be conducted under the Level 1 Discovery Control Plan. Pursuant to Rule 190.2(a)(1), TRCP, Petitioner affirmatively pleads that it seeks only monetary relief aggregating fifty thousand and no/100 dollars (\$50,000.00) or less, excluding costs, pre-judgment interest and attorneys' fees.

#### II. NATURE OF PROCEEDING

Petitioner brings this disciplinary action pursuant to the STATE BAR ACT, TEXAS GOVERNMENT CODE ANNOTATED §81.001, et seq. (Vernon 1988 and supp. 1994); the TEXAS

DISCIPLINARY RULES OF PROFESSIONAL CONDUCT; and the TEXAS RULES OF DISCIPLINARY PROCEDURE.

#### III. <u>VENUE</u>

Respondent is an attorney licensed to practice law in Texas and is a member of the STATE BAR OF TEXAS. Respondent's residence and principal place of practice is Harris County, Texas; therefore, venue is appropriate in Harris County, Texas, pursuant to Rule 3.03 of the TEXAS RULES OF DISCIPLINARY PROCEDURE. Respondent may be served at his business address, 333 N. Sam Houston Parkway E., Suite 400, Houston, Harris County, Texas, 77060.

### IV. CAUSE OF ACTION

On or about May 1, 1998, GENE ROWAN (hereinafter referred to as "ROWAN") hired Respondent to represent him in two (2) civil actions, Cause No 98CV0466, <u>W. Kevin Bateman</u>, <u>Individually and W. Kevin Bateman, Inc. d/b/a Ventec v. Gene Rowan, Individually and d/b/a</u> <u>River Road Machine Manufacturing Co.</u>, In the 10th Judicial District Court of Galveston County, Texas (hereinafter referred to as "the Bateman suit") and Cause No. 98CV0323, <u>Jen-</u> <u>Cyn Enterprise's, Inc. v. Gene Rowan, Individually, and d/b/a River Road Machines</u>, In the 212th Judicial District Court of Galveston County, Texas (hereinafter referred to as "the Jen-Cyn suit").

Thereafter, Respondent was suspended from the practice of law beginning November 1, 1998, and ending January 31, 1999. By letter dated October 30, 1998, Respondent notified ROWAN and the Courts of his suspension and his withdrawal from the *Bateman* suit and the *Jen-Cyn* suit. However, Respondent failed to give ROWAN reasonable notice of his withdrawal to allow ROWAN to hire other counsel.

Original Disciplinary Petition - Hamm J:\HAMM\CFLD2.JAH\PLEADING\DP.WPD Additionally, Respondent failed to protect ROWAN'S interests in the *Bateman* suit when on or about May 24, 1999, ROWAN received from Respondent a *Notice of Hearing* for a hearing scheduled for May 24, 1999, as well as six (6) unopened envelopes from the opposing counsel. The unopened envelopes were mailed to Respondent between the dates of January 27, 1999, and April 26, 1999. As a result, a default judgment was rendered against ROWAN.

### V. RULE VIOLATIONS

The acts and/or omissions of Respondent described in Paragraph IV above constitute conduct in violation of Rules 1.15(d) [upon termination of representation, a lawyer shall take steps to the extent reasonably practicable to protect a client's interests, such as giving reasonable notice to the client, allowing time for employment of other counsel, surrendering papers and property to which the client is entitled, and refunding any advance payments of fee that has not been earned]; and 8.04(a)(1) [a lawyer shall not violate the TEXAS DISCIPLINARY RULES OF PROFESSIONAL CONDUCT, knowingly assist or induce another to do so, or do so through the acts of another, whether or not such violation occurred in the course of a client-lawyer relationship], of the TEXAS DISCIPLINARY RULES OF PROFESSIONAL CONDUCT.

#### VI.

The complaint that forms the basis of this cause of action was brought to the attention of the Office of the Chief Disciplinary Counsel of the STATE BAR OF TEXAS by GENE ROWAN'S filing of a complaint on July 26, 1999.

HAMM, by reprimand, suspension, or disbarment, as the facts shall warrant; order restitution to Complainant; and grant all other relief to which Petitioner may show itself to be justly entitled, including costs of court and attorneys' fees.
