Comes now, Petitioner, COMMISSION FOR LAWYER DISCIPLINE, a committee of the State Bar of Texas, complaining of Respondent, HYLON L. ADAMS, and in support thereof would respectfully show the Court the following:

Parties

Petitioner is the COMMISSION FOR LAWYER DISCIPLINE, a committee of the State Bar of Texas. Respondent, HYLON L. ADAMS, Texas State Bar Number 00860400, is an attorney licensed to practice law in the State of Texas and is a member of the State Bar of Texas. Respondent is a resident of Bexar County, Texas. Respondent may be served with citation and a copy of this petition by serving him at his principal place of business located at <u>8026 Vantage, Suite</u> <u>106, San Antonio, Texas 78230</u>.

<u>Venue</u>

Respondent's principal place of law practice is in Bexar County, Texas. Accordingly, pursuant to Texas Rules of Disciplinary Procedure 3.03, venue is proper in Bexar County, Texas.

Discovery Control Plan

Petitioner intends to conduct discovery under Level 2 of Rule 190.3 of the Texas Rules of Civil Procedure.

I.

Petitioner brings this disciplinary action pursuant to State Bar Act, Tex. Gov't. Code Ann., Sec. 81.001, <u>et seq.</u> (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of this action was filed by Ms. Angella D. Veve and Oscar J. Limon on or about September 15, 1999. The acts and conduct of Respondent, as hereinafter alleged, constitute professional misconduct.

II.

1. On or about August 26, 1998, the complainants hired Respondent to represent them in a personal injury claim arising from an auto accident on August 21, 1998. Respondent after being discharged by the complainants refused to return the complainants complete legal file and medical records, attempting to charge them \$1.00 per page claiming that the file was more than 120 pages long. Only 41 pages were returned to the complainant.

2. During settlement negotiations the Respondent and his staff tried to persuade the complainants to tell the insurance adjuster that they had received over \$350.00 in prescription medication from Hills Pharmacy when in fact the Respondent's employees knew this was false. The complainants had in fact only received a few samples of medication before they were even examined by clinic personnel.

The complainants were referred to a medical clinic by either a family member or friend.
While at the clinic for their first visit, the staff referred Complainants to Respondent's office and

Complainants were driven to Respondent's office by a member of the clinic's staff. The referral

to Respondent was unsolicited by the Complainants.

III.

The conduct of Respondent described above constitutes a violation of the following Texas

Disciplinary Rules of Professional Conduct:

Rule 1.02(c) -- A lawyer shall not assist or counsel a client to engage in conduct that the lawyer knows is criminal or fraudulent.

Rule 4.01(a) -- A lawyer shall not knowingly make a false statement of material fact or law to a third person

Rule 4.01(b) -- A lawyer shall not knowingly fail to disclose a material fact to a third person when disclosure is necessary to avoid making the lawyer a party to a criminal act or knowingly assisting a fraudulent act perpetuated by a client.

Rule 5.03(a) -- A lawyer having direct supervisory authority over the nonlawyer shall make reasonable efforts to ensure that the persons conduct is compatible with the professional obligations of the lawyer.

Rule 5.03(b) -- A lawyer shall be subject to discipline for the conduct of such a person that would be a violation of these rules if engaged in by a lawyer if:

(1) the lawyer orders, encourages, or permits the conduct involved; or

(2) the lawyer:

(I) is a partner in the law firm in which the person is employed, retained by, or associated with; or is the general counsel of a government agency's legal department in which the person is employed, retained by or associated with; or has direct supervisory authority over such person; and

(ii) with knowledge of such misconduct by the nonlawyer knowingly fails to take reasonable remedial action to avoid or mitigate the consequences of that persons misconduct.

Rule 8.04(a)(2) -- A lawyer shall not commit a serious crime or commit any other criminal act that reflects adversely on the lawyer's honesty, trustworthiness or fitness as a lawyer in other respects.

Rule 8.04(a)(3) -- A lawyer shall not engage in conduct involving dishonesty, fraud, deceit or misrepresentation.

WHEREFORE, PREMISES CONSIDERED, Petitioner prays that a judgment of professional misconduct be entered against Respondent imposing an appropriate sanction as the facts shall warrant and that Petitioner have such other and further relief to which it is entitled, including costs of court, restitution, and reasonable attorney fees.
