#### **DISCIPLINARY PETITION**

#### TO THE HONORABLE JUDGE OF SAID COURT:

Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complains of Respondent, David K. Line, (hereinafter called "Respondent"), showing the Court:

I.

### **Discovery Control Plan**

Pursuant to Rules 190.1 and 190.2, TEXAS RULES OF CIVIL PROCEDURE (TRCP), Petitioner intends discovery in this case to be conducted under the Level II Discovery Control Plan.

II.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

III.

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Dallas County, Texas.

#### IV.

In or about April 1998, Robert Williams ("Williams") retained Respondent to represent Williams and his children in a personal injury claim relating to toxic exposure to formaldehyde emanating from a new mobile home in which Williams and his children were living. Thereafter, Respondent neglected Williams' case. Williams called Respondent's office long distance on ten or twelve occasions to determine the status of his case, but was able to talk to Respondent only one time. Williams also wrote Respondent several times inquiring about the status of his case, but received no response. Respondent wrote Williams on or about February 2, 1999, declining representation of Williams. During the withdrawal of the representation, Respondent failed to inform Williams that the statute of limitations on his case would run in August 1999. Further, Respondent failed to return Williams' file until May 28, 1999.

V.

Such acts and/or omissions on the part of Respondent as are described in Paragraph IV, hereinabove, which occurred on or after January 1, 1990, constitute conduct which violates Rules 1.01(b)(1), 1.03(a), 1.15(b)(1), and 1.15(d) of the Texas Disciplinary Rules of Professional Conduct.

#### VI.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of the Chief Disciplinary Counsel of the State Bar of Texas by Robert Williams filing a complaint on or about March 21, 1999.

#### **PRAYER**

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
