Additionally, David Joseph Morales must provide immediate written notification of the revocation to each of his clients. He shall return any files, papers, unearned funds, and other property in his possession belonging to any client or former client to the client or former client or

all files, papers, funds, and other property belonging to all clients and former clients have been

Finally, David Joseph Morales shall, within thirty (30) days after the date of this Order, provide written notice of the terms of this Order to each justice of the peace, judge, magistrate, and chief justice of each court in which he has any pending matter and shall therein identify the style and cause number of the pending matter with the name, address, and telephone numbers of each client he represents in each court. David Joseph Morales shall file with the State Bar of Texas, Office of the Chief Disciplinary Counsel, Texas Law Center, 1414 Colorado Street, Austin, Texas 78701, within thirty (30) days after the date of this Order, an affidavit stating that he has provided written notice to each justice of the peace, judge, magistrate, and chief justice of each court in which he has any pending matter, including the style and cause number of the pending matter with the name, address, and telephone numbers of each client he represents in each court.

This Order shall be effective immediately.
