There is hereby allocated and appropriated from the Judicial and Court Personnel Training Fund grants and administration funds \$76,350 for the period beginning September 1, 1991 and ending August 31, 1992, to be used for the Special Study on the operations and management of the judicial and court personnel education programs as heretofore authorized by the Supreme Court of Texas.

There is hereby allocated and appropriated from the Judicial and Court Personnel Training Fund \$113,190 for the period beginning September 1, 1991 and ending August 31, 1992, to the State Office of Court Administration to be used for the administration of the Judicial and Court Personnel Training Fund, including \$20,000 in Retained Reserve for possible use in the Special Study authorized by the Court.

The expenditure of all funds granted or allocated hereby shall meet all regulations of the State of Texas and all orders, rules, and regulations as may be from time to time promulgated by the Supreme Court.
