DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, Harold J. Eisenman (hereinafter called "Respondent"), showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, <u>et seq.</u> (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

П.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of business in Harris County, Texas. An officer may serve citation on Respondent at his business address located at 1900 West Loop South, Suite 1420, Houston, Harris County, Texas 77027. On or about March 26, 1990, Louis C. Wishum (hereinafter called "Wishum") was injured in the course of his employment with the Southern Pacific Railroad (hereinafter called "Southern Pacific"). Southern Pacific thereafter offered to settle Wishum's worker's compensation claim for \$250,000.00.

IV.

Wishum decided not to accept Southern Pacific's settlement offer, and instead hired an attorney, Charles W. Medlin (hereinafter called "Medlin") to represent him. The parties signed a contract of employment on or about May 12, 1992, that expressly provided that attorney's fees would be paid to Medlin only in the event Medlin was able to obtain a settlement on Wishum's behalf that exceeded \$250,000.00; otherwise, Medlin would not be paid any attorney's fees.

V.

Medlin thereafter engaged the services of Respondent to assist in his representation of Wishum. Wishum did not sign a new or additional contract for services with Respondent. Respondent settled Wishum's case with Southern Pacific in early September, 1993, for \$250,000.00. On or about September 14, 1993, Respondent sent Wishum a list detailing attorney's fees and expenses he intended to deduct from the settlement proceeds at the time he disbursed the proceeds. The deductions included payment of attorney's fees to Respondent in the amount of \$30,000.00. The deduction for attorney's fees was made by Respondent notwithstanding the fact that the parties' contract for services expressly provided that no attorney's fees would be paid to him unless Wishum's recovery exceeded \$250,000.00. When Wishum protested payment of the attorney's fees, Respondent indicated that he felt he was

entitled to the money for all the work he had performed on the case prior to settlement. When Respondent later disbursed the settlement proceeds, he paid himself the \$30,000.00 in attorney's fees.

VI.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs III., IV. and V. hereinabove which occurred on or after January 1, 1990, constitute conduct which violates Rule 1.04(a) of the Texas Disciplinary Rules of Professional Conduct.

VII.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by Louis C. Wishum filing a complaint on or about September 21, 1993.

<u>PRAYER</u>

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
