DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, James V. Mazuca, (hereinafter called "Respondent"), showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

П.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Bexar County, Texas. An officer may serve citation on Respondent at his business address located at 511 West French Place, San Antonio, Bexar County, Texas 78212.

On or about July 26, 1993, Lisa A. Bohannon (hereinafter called "Bohannon") hired Respondent to represent her in a personal injury claim for damages she had recently sustained in an automobile accident.

IV.

Bohannon thereafter became dissatisfied with Respondent's representation and terminated his employment on or about September 14, 1993. Approximately two weeks later, she changed her mind and rehired Respondent to represent her. However, after rehiring Respondent, Bohannon again grew concerned with the quality of his representation, particularly since she was unable to meet with him or discuss her case with him personally. As a result, she terminated his employment on or about October 20, 1993.

V.

Following the termination of his employment, Bohannon asked Respondent for a copy of her file, including her contract of employment. Respondent failed and/or refused to provide Bohannon with a copy of her file, purportedly because all the documents in the file had allegedly been mailed to her on prior occasions by Respondent's staff. Bohannon also requested that Respondent release his interest in her case so that she could hire another attorney to represent her. Respondent informed Bohannon that he was maintaining his interest in the case and planned to collect a share of the attorney's fees at the time of settlement.

VI.

Notwithstanding the fact that his representation had been terminated by Bohannon, Respondent thereafter failed to promptly notify the defendant's insurance company that he was

withdrawing from his representation of Bohannon, thereby effectively preventing other counsel from representing her. Respondent did not notify the insurance company of his termination until on or about March 25, 1994, one day after a hearing was held on the matter before the District 10B Grievance Committee of the State Bar of Texas.

VII.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs III., IV., V. and VI. hereinabove which occurred on or after January 1, 1990, constitute conduct which violates Rules 1.03(a), 1.03(b), 1.15(a)(3), and/or 1.15(d) of the Texas Disciplinary Rules of Professional Conduct.

VIII.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by Lisa A. Bohannon filing a complaint on or about December 10, 1993.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
