DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, Robert Charles Brown, (hereinafter called "Respondent"), showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

II.

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Dallas County, Texas. An officer may serve citation on Respondent by and through his attorney of record, Ruth A. Kollman, at 6517 Hillcrest, Suite 209, Dallas, Texas 75205.

III.

While a partner in a law firm, Respondent represented a client in two litigation matters.

Pursuant to one of these matters, Respondent's client forwarded \$10,000.00 to the firm to hold for the possible payment of a third party claim. The funds were deposited in the firm's trust account.

IV.

During 1994, it became evident that the third party would not claim the funds Respondent's client had on deposit in the firm's trust account. During this same time period, the amount of unpaid legal fees for work Respondent performed for the client in the two litigation matters exceeded \$10,000.00. In or about January, 1995, Respondent directed the firm's bookkeeper to issue three (3) checks (totaling \$9,053.92) from the firm's trust account to pay for Respondent's personal expenses. At no time prior to taking this action did Respondent: (1) contact the client and request that the \$10,000.00 be applied to the outstanding legal fees; or (2) apply the \$10,000.00 to the outstanding legal fees, deposit the funds in the firm's operating account, and then report to the firm that the outstanding fees had been collected.

V.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs III and IV, hereinabove, which occurred on or after January 1, 1990, constitute conduct which violates Rules 1.14(a), 1.14(c) and/or 8.04(a)(3) of the Texas Disciplinary Rules of Professional Conduct.

VI.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by James A. Williams filing a complaint on or about December 19, 1996.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
