DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, Catherine M. Shelton, (hereinafter called "Respondent"), showing the Court:

I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

II.

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Dallas County, Texas. An officer may serve citation on Respondent by and through her attorney, Steven L. Lee, 3921 Steck Avenue #A119, Austin, Texas 78759-8647.

III.

On or about June 3, 1997, Barry L. Wright ("Wright") hired Respondent to represent him in

a parole revocation matter. Respondent was paid \$1,000.00 in legal fees, plus an investigator's fee of \$250. Thereafter, Respondent failed to keep Wright reasonably informed about the status of his matter and promptly comply with reasonable requests for information. Respondent failed to return Complainant's telephone calls, and she failed to respond to Complainant's correspondence requesting information about the status of his case. Additionally, Respondent failed to carry out the obligations she owed to her client. Complainant arrived late and unprepared for both Complainant's June 9, 1997, preliminary hearing and his August 7, 1997, revocation hearing.

IV.

After Complainant's parents paid Respondent an additional \$1,000.00 in legal fees to continue representing their son, for a total of \$2,250.00, both Complainant and his parents asked Respondent for an itemized statement or an accounting of her fees for services rendered and her expenses. Respondent failed to comply with said requests and never provided an accounting.

V.

As a result of the conduct described in Paragraphs III and IV, Complainant filed a complaint against Respondent with the State Bar of Texas on September 23, 1997. On October 7, 1997, the State Bar of Texas sent, by certified mail return receipt requested, a letter to Respondent notifying her that a complaint alleging professional misconduct on his part had been filed against her by Complainant. In said letter, Respondent was advised that, pursuant to Rule 2.09 of the Texas Rules of Disciplinary Procedure, she was required to file a written response with the State Bar of Texas within thirty (30) days of her receipt of the letter. Thereafter, Respondent contacted the State Bar of Texas and requested an extension of time in which to respond. Respondent's request was granted

and her time for filing her response was extended until December 7, 1997, at 5:00 p.m. Respondent has failed to furnish the State Bar of Texas a written response to the complaint and she failed to timely assert a privilege or other legal ground for her failure to furnish her response.

VI.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs III and IV, hereinabove, which occurred on or after January 1, 1990, constitute conduct which violates Rules 1.01(b)(2), 1.03(a)(b), 1.14(b) and/or 8.04(a)(1)(8) of the Texas Disciplinary Rules of Professional Conduct.

VII.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by Barry L. Wright filing a complaint on or about September 23, 1997.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
