DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

Comes now, Petitioner, COMMISSION FOR LAWYER DISCIPLINE, a committee of the State Bar of Texas, complaining of Respondent, RENE SEGUNDO, and in support thereof would respectfully show the Court the following:

Parties

Petitioner is the COMMISSION FOR LAWYER DISCIPLINE, a committee of the State Bar of Texas. Respondent, RENE SEGUNDO, Texas State Bar Number 17996999, is an attorney licensed to practice law in the State of Texas and is a member of the State Bar of Texas. Respondent is a resident of Hidalgo County, Texas. Respondent may be served with citation and a copy of this petition by serving him at his place of business located at 4409 North 22nd Street, McAllen, Texas 78502-6226.

Venue

Respondent's principal place of law practice is in Hidalgo County, Texas. Accordingly, pursuant to Texas Rules of Disciplinary Procedure 3.03, venue is proper in Hidalgo County, Texas.

I.

Petitioner brings this disciplinary action pursuant to State Bar Act, Tex. Gov't. Code Ann., Sec. 81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of this action was filed on or about April 29, 1997. The acts and conduct of Respondent, as hereinafter alleged, constitute professional misconduct.

II.

- 1. Respondent was retained sometime between September 1993 and February 1994 for representation on a personal injury suit.
- 2. Despite numerous attempts by Respondent's clients to contact Respondent about the status of the case, Respondent refused to take and/or failed to return his clients' telephone calls.
- 3. On or about May 27, 1997, the trial court granted a Motion for Sanctions against Respondent's clients for their failure to appear for depositions in the suit. The court ordered Respondent's clients to appear for depositions on June 19, 1997.
- 4. In or around June 1997, Respondent filed a Motion to Withdraw from the suit.
- 5. The trial court signed the Order Permitting Withdrawal on July 30, 1997.

- 6. On or about June 19, 1997, Respondent failed to appear at depositions previously ordered by the trial court and failed to timely and adequately inform his clients of their need to appear at said depositions.
- 7. Respondent likewise failed to appear at a subsequent hearing on a Motion to Compel and failed to protect his clients' interests in their suit prior to his withdrawal on or about July 30, 1997.

III.

The conduct of Respondent described above constitutes a violation of the following Texas

Disciplinary Rules of Professional Conduct:

Rule 1.01(b)(1) -- In representing a client, a lawyer shall not neglect a legal matter entrusted to the lawyer.

Rule 1.03(a) -- In representing a client, a lawyer shall keep a client reasonably informed about the status of a matter and promptly comply with reasonable requests for information.

Rule 1.03(b) -- In representing a client, a lawyer shall explain a matter to the extent reasonably necessary to permit the client to make informed decisions regarding the representation.

Rule 1.15(b)(1)-- A lawyer shall not withdraw from representing a client unless withdrawal can be accomplished without material adverse effect on the interests of the client.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays that a judgment of professional misconduct be entered against Respondent imposing an appropriate sanction as the facts shall warrant and that Petitioner have such other relief to which it is entitled, including costs of court and attorney's fees.

Touche Ross Co., 946 S.W.2d 862 (Tex.App.- Houston [14th Dist.] 1997), which requires that all proceedings incident to a case occur in the county of proper venue. If not, I would respectfully request that an alternate appointment be made.

Once a trial judge has been appointed, please forward the original and three (3) copies of the Disciplinary Petition, the filing fee check, also enclosed herewith, and the Court's appointing

order to the District Clerk of Hidalgo County, Texas, with the request that the suit be filed, service be obtained, and a filemarked copy of the petition returned to the undersigned.
