If not, I would respectfully request that an alternate appointment be made.

#### TO THE HONORABLE JUDGE OF THE COURT:

#### 2. VENUE

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of Harris County, Texas.

Respondent's principal place of practice is Harris County, Texas. Therefore, venue is appropriate in Harris County, Texas, pursuant to Rule 3.03 of the Texas Rules of

Disciplinary Procedure.

#### 4. O' BRIEN'S COMPLAINT

PURSUANT TO PART III OF THE TEXAS RULES OF DISCIPLINARY PROCEDURE, PETITIONER REQUESTS THIS COURT TO DISCIPLINE HURDER FOR ACTS OF PROFESSIONAL MISCONDUCT.

# 4.01 HURDER ENGAGED IN CONDUCT VIOLATING TEXAS DISCIPLINARY RULE OF PROFESSIONAL CONDUCT

- 3.03(a)(1) [make a false statement of material fact or law to a tribunal];
- **8.04(a)(1)** [a lawyer shall not violated these rules, knowingly assist or induce another to do so whether or not such violation occurred in the course of a client-lawyer relationship];
- **8.04(a)(2)** [commit a serious crime or commit any other criminal act that reflects adversely on the lawyer's honesty trustworthiness or fitness as a lawyer in other respects];
- **8.04(a)(3)** [for engaging in conduct involving dishonesty, fraud, deceit or misrepresentation];
- 8.04(a)(4) [for engaging in conduct constituting obstruction of justice].

- (A) On or about April 4, 1997, Respondent, appeared in Harris County Criminal Court at Law No. 14, representing a client, Michelle Cummins ("Cummins").
- (B) On or about April 4, 1997, Cummins, did not appear and answer the Courts docket call.
- (C) Respondent, in his representation of Cummings, knowingly assisted a party, Sandy Butler, a friend of Cummins, to falsify a case reset form without Cummins knowledge or consent.
- (D) Respondent knowingly presented the falsified case reset form to the Court as having been signed by Cummins.
- (E) By engaging in conduct that was dishonest, deceitful and an obstruction of justice, Respondent has violated the Texas Disciplinary Rules of Professional Conduct.

#### 5.0 PRAYER

Petitioner respectfully prays that this Court discipline Respondent by disbarment, suspension or reprimand, as the facts shall warrant; and that the Petitioner have all other relief to which it may show itself to be justly entitled including costs of court and attorneys' fees.
