## ORIGINAL DISCIPLINARY PETITION

#### TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the COMMISSION FOR LAWYER DISCIPLINE, a committee of the State Bar of Texas (hereinafter referred to as "Petitioner"), complaining of Respondent, JACK G. SWISHER, JR., (hereinafter referred to as "Respondent"), and would show the Court the following:

### I. NATURE OF PROCEEDING

Petitioner brings this disciplinary action pursuant to the State Bar Act, the Tex.Gov't Code Annotated. §81.001, et seq. (Vernon 1988 and supp. 1994), the Texas Disciplinary Rules of Professional Conduct, and the Texas Rules of Disciplinary Procedure. The complaint that forms the basis of this Original Disciplinary Petition were filed on or after May 1, 1992.

#### II. <u>VENUE</u>

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Harris County, Texas; therefore, venue is appropriate in Harris County, Texas, pursuant to Rule 3.03 of the Texas Rules of Disciplinary Procedure. An officer may serve citation on Respondent Jack G. Swisher, Jr., at his place of business, 778 Bateswood, #2, Houston, Texas 77079.

#### III. CAUSE OF ACTION

On or about October 6, 1996, Respondent was employed to represent Complainant in a workers compensation claim. Thereafter, the Complainant never heard from the Respondent. Respondent had failed to keep the Complainant informed as to the status of his case.

#### IV.

The complaint that forms the basis of this cause of action was brought to the attention of the Office of the General Counsel of the State Bar of Texas by Kamthigasen Naidoo's filing of a complaint on or about April 25, 1997.

## V. RULE VIOLATIONS

The acts and/or omissions of Respondent described in Paragraph III above which occurred on or before January 1, 1990, constitute conduct in violation of Rules 1.03 [for failing to keep the client reasonably informed about the status of a matter and promptly comply with reasonable requests for information].

#### **PRAYER**

WHEREFORE, PREMISES CONSIDERED, Petitioner, COMMISSION FOR LAWYER DISCIPLINE, respectfully prays that this Court discipline Respondent, JACK G. SWISHER, JR., by reprimand, suspension, or disbarment, as the facts shall warrant; restitution; and all other relief to which Petitioner may show itself to be justly entitled, including costs of court and attorneys' fees.
