## DISCIPLINARY PETITION

## TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of ${ }^{\prime}$ Texas (hereinafter called "Petitioner"), complaining of Respondent, Roger F. Joyner, (hereinafter called "Respondent"), showing the Court:
I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. $\S 81.001$, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

## II.

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Dallas County, Texas. An officer may serve citation on Respondent by and through his attorney of record, Lyle Medlock, 1801 N. Hampton Road, Suite 300, De Soto, Texas 75115-2399.

## FIRST CAUSE OF ACTION

## III.

On or about October 1995, Melvin Hightower ("Hightower") hired Respondent to represent him in two misdemeanor cases in the Dallas County Criminal Court. Prior to the conclusion of the criminal matters, Hightower became dissatisfied with Respondent's services and terminated Respondent's employment in September 1997. At the time of the termination of Respondent's representation, Hightower made a request for his files. Respondent has failed to provide Hightower with his files.

## IV.

As a result of the conduct described in Paragraph III, Hightower filed a complaint against Respondent with the State Bar of Texas on December 5, 1997. On December 11, 1997, the State Bar of Texas sent, by certified mail, return receipt requested, a letter to Respondent notifying him that a complaint alleging professional misconduct on his part had been filed against him by Hightower. In said letter, Respondent was advised that, pursuant to Rule 2.09 of the Texas Rules of Disciplinary Procedure, he was required to file a written response with the State Bar of Texas within thirty (30) days of his receipt of the letter. Respondent received the letter on December 12, 1997, and failed to furnish the State Bar of Texas a written response to the complaint.

## V.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs III and IV, hereinabove, which occurred on or after January 1, 1990, constitute conduct which violates Rules 1.15 (d) and 8.04(a) (8) of the Texas Disciplinary Rules of Professional Conduct.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by Melvin Hightower filing a complaint on or about December 5, 1997.

## SECOND CAUSE OF ACTION

## VII.

On or about May 5, 1995, Carlos Galvan ("Galvan") hired Respondent to represent him in a wrongful termination claim against the Dallas Fire Department and paid Respondent $\$ 5,000.00$. Thereafter, Respondent failed to Galvan reasonably informed about the status of the matter and failed to comply with Galvan's numerous attempts (both by phone and in person) to obtain information regarding his case.
VIII.

After the September 14, 1995 hearing, which resulted in an adverse ruling against Galvan, Galvan terminated Respondent and requested Respondent return his files and personal property in Respondent's possession. Respondent failed to return Galvan's files and personal property as requested.

## IX.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs VII, VIII and IX, hereinabove, which occurred on or after January 1, 1990, constitute conduct which violates Rules 1.03 and $1.15(\mathrm{~d})$ of the Texas Rules of Professional Conduct.

## X.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by Carlos Galvan filing a complaint on or about April 1, 1998.

## PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.

As a practical matter, I would respectfully suggest that you inquire with the judge to be appointed as to: (1) whether he or she will be able to comply with the 180 day deadline by which the case must be set for trial set forth in Section 3.07 of the Texas Rules of Disciplinary Procedure; and (2) whether he or she can accommodate compliance with Mellon Service Co., et al v. Touche Ross Co., 946 S.W.2d 862 (Tex. App. - Houston [14th Dist.] 1997), which requires that all proceedings incident to a case occur in the county of proper venue. If not, I would respectfully request that an alternate appointment be made.

Once a trial judge has been appointed, please forward the original and two (2) copies of the Disciplinary Petition, the filing fee check, also enclosed herewith, and the Court's appointing order to the District Clerk of Dallas County, Texas, with the request that the suit be filed, service be obtained, and a file-marked copy of the petition be returned to the undersigned.

Also enclosed are a pre-addressed envelope for your use in transmitting the petition, etc., to the District Clerk of Dallas County, Texas, and a return envelope to be sent to the District Clerk of Dallas County, Texas, for the Clerk's use in returning a file-marked copy of the Petition to the undersigned.
