


II.

IN THE SUPREME COURT OF TEXAS RESPONSE TO MOTION FOR ACCEPTANCE OF RESIGNATION AS ATTORNEY AND COUNSELOR AT LAW

OF

J. PATRICK GUERRA

TO THE HONORABLE SUPREME COURT OF TEXAS:

Pursuant to Part X of the Texas Rules of Disciplinary Procedure, Steven W. Young, Chief Disciplinary Counsel, hereby files this response on behalf of the State Bar of Texas, acting by and through the Commission for Lawyer Discipline, to the Motion for Acceptance of Resignation filed by J. Patrick Guerra, and would show as follows:

I.

On March 2, 1999, J. Patrick Guerra, State Bar No. 08576160 (hereinafter the "Movant"), executed the Motion for Acceptance of Resignation. The acceptance by the Court of the Resignation of J. Patrick Guerra is in the best interest of the public and of the profession.

II.

- (1) In Case No. S0049806411, filed by Complainant, Carlos Ortegon (hereinafter "Ortegon"), on April 16, 1998, Movant was hired by Ortegon in March of 1997 to pursue a child custody modification matter. Ortegon paid approximately \$7,000.00 in attorney fees to Movant for the representation.
- (2) A trial was held on August 25 26, 1997, at which time the court awarded custody to Ortegon. Thereafter, Movant failed to finalize the case by failing to prepare and enter final orders in the matter.
- (3) Movant failed to respond to Ortegon's numerous phone calls and requests for information on the status of his case.

- (4) In Case No. S0059806513, filed by Complainant, Olivia G. Beck (hereinafter "Beck"), on May 26, 1998, Movant was hired by Beck on October 8, 1996 to pursue a child custody modification matter. Beck paid \$1,000.00 in attorney fees to Movant for the representation.
- (5) A hearing was held on November 4, 1996, at which time the court awarded custody to Beck. Thereafter, Movant failed to finalize the case by failing to prepare and enter final orders in the matter.
- (6) Movant failed to respond to Beck's numerous phone calls and requests for information on the status of her case.
- (7) In Case No. S107902008, filed by Complainant, Rose Marie Johnson (hereinafter "Johnson"), on July 15, 1998, Johnson hired Movant in June of 1997 to represent her in a divorce.
- (8) Movant neglected the legal matter entrusted to him by failing to forward settlement offers made by Johnson's ex-husband to Johnson for consideration and by failing to provide Johnson with copies of other correspondence related to her case.
- (9) Movant received notice of Johnson's grievance from the State Bar of Texas on or about August 12, 1998, by private process service. Movant's written response to the complaint was due on or before September 11, 1998. Movant failed to timely file a written response or to assert legal ground for failure to do so.
- (10) On November 10, 1998, Movant was served by private process service with notice that a hearing on this complaint was set on December 18, 1998 before Panel 11C-2 of the District 11C Grievance Committee. Movant failed to appear at that hearing and failed to make any response to the allegations made by Johnson.
- (11) Restitution in the amount of \$ 7,000.00 is due and payable to Ortegon and restitution in the amount of \$ 1,000.00 is due and payable to Beck.

(12)The conduct of Movant described above constitutes a violation of the following Texas Disciplinary Rules of Professional Conduct: Rules 1.01(b)(1), 1.03(a), 1.03(b), 8.01(b), and 8.04(a)(8).

III.

WHEREFORE, the State Bar of Texas moves the Court to accept the resignation and grant the motion filed by Movant.
