DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas ("Petitioner"), complaining of Respondent, Susan J. Scolaro ("Respondent"), showing the Court:

I.

Pursuant to Rule 190.1, Texas Rules of Civil Procedure (TRCP), discovery in this case is governed by Discovery Control Plan - Level 2, as provided in Rule 190.3, TRCP.

П.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. § 81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

III.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of, and has her principal place of practice in, Lubbock, Lubbock County, Texas. An officer may serve citation on Respondent at 4610 15th Street, Lubbock, Texas 79416-4812.

A. In a Spring 1998 primary election in Lubbock County, Texas, Respondent was one of the candidates running for County Court at Law Judge. During the campaign, Respondent made statements against the opposing candidate, a licensed attorney and sitting Associate Judge, which misrepresented her opponent's qualifications and made it appear that the opponent was ineligible for the position of County Judge.

Such acts and/or omissions on the part of Respondent as are described in Paragraph IV.A. above occurred on or after January 1, 1990, and constitute conduct violative of Rule(s) 8.02(a) and 8.04(a)(1)(3) of the Texas Disciplinary Rules of Professional Conduct, Article X, Section 9, State Bar Rules.

B. Respondent misrepresented her eligibility for candidacy. Respondent made statements to the media and public that she had been on inactive status, but began practicing law on September 1, 1994, a date more than fours years prior to the general election in November 1998. Additionally, Respondent, in an affidavit submitted to a Texas appellate court, Respondent stated that she had begun practicing law - principally representing her husband - on September 1, 1994 in preparation of assuming a position as an attorney with the Criminal District Attorney's office in January 1999.

However, contradicting these representations made in furtherance of her candidacy for judge, Respondent, in regards to the issue of payment of her attorney occupational tax due for 1994, represented to the State Bar of Texas that she was not practicing law in 1994.

Such acts and/or ommissions on the part of Respondent as are described in Paragraph IV.B. above occurred on or after January 1, 1990, and constitute conduct violative of Rule(s) 8.04(a)(1)(3) of the Texas Disciplinary Rules of Professional Conduct, Article X, Section 9, State Bar Rules.

The complaint which forms the basis of the cause of action hereinabove set forth was brought to the attention of the Office of the General Counsel of the State Bar of Texas by a complaint filed by the State Bar of Texas on or about March 19, 1998.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorneys' fees.

Touche Ross Co., 946 S.W.2d 862 (Tex. App. - Houston [14th Dist.] 1997), which requires that all proceedings incident to a case occur in the county of proper venue. If not, I would respectfully request that an alternate appointment be made.

Once a trial judge has been appointed, please forward the original and two (2) copies of the Disciplinary Petition, the filing fee check, also enclosed herewith, and the Court's appointing order to the District Clerk of Lubbock County, Texas, with the request that the suit be filed, service be obtained, and a file-marked copy of the petition be returned to the undersigned.

Dear Judge Chapman:
