DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent. Paul R. Alexander, (hereinafter called "Respondent"), showing the Court:

I.

Discovery Control Plan

Pursuant to Rules 190.1 and 190.2, TEXAS RULES OF CIVIL PROCEDURE (TRCP), Petitioner intends discovery in this case to be conducted under the Level II Discovery Control Plan.

II.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

III.

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of and has his principal place of practice in Dallas County, Texas.

An officer may serve citation on Respondent at 2401 Turtle Creek Blvd., Dallas, Texas 75219.

IV.

On or around June 1996. Respondent substituted in as counsel of record in Habib Abedinzadeh's (Habib) Workman's Compensation case pending in district court. This was done without the knowledge or consent of Habib. Habib never consulted or met with Respondent, but rather met with Jack Swisher who was practicing law (while administratively suspended by the State Bar of Texas) under the name of Respondent. By allowing Swisher to conduct business under Respondent's name, Respondent was actually assisting Swisher in the unauthorized practice of law. Respondent never met with Habib, never knew who Habib was and never reviewed or oversaw the work performed by Swisher.

V.

On or about September 26, 1996, Complainant learned Respondent failed to respond to a motion to compel or a motion for sanctions filed by opposing counsel. Opposing counsel had filed the motion for sanctions due to Respondent's failure to comply with an order compelling Habib to respond to discovery. A hearing was held on the motion for sanctions on August 30, 1996, at which time the judge signed an order striking Habib's pleading and making a final ruling in favor of the opposing party.

VI.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs IV and V, hereinabove, which occurred on or after January 1, 1990, constitute conduct which violates Rules 1.01(a)(1), 1.03(a), 5.05(b), and 8.04(a)(3) of the Texas Disciplinary Rules of Professional Conduct.

VII.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by Habib Abedinazdeh, filing a complaint on or about August 26, 1997.

PRAYER

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
