### ORDER OF THE SUPREME COURT OF TEXAS

#### IN THE MATTER OF FELIPE JUAREZ

On this day, the Court considered the Motion for Acceptance of Resignation as Attorney and Counselor at Law of Felipe Juarez, together with the Response of the Chief Disciplinary Counsel to the Motion for Acceptance of Resignation as Attorney and Counselor at Law of Felipe Juarez. The Court has reviewed said Motion and Response and finds that each meets the requirements of Part X of the Texas Rules of Disciplinary Procedure. In conformity with Part X, Section 10.02 of the Texas Rules of Disciplinary Procedure, the Court considers the detailed statement of professional misconduct contained within the Response of Chief Disciplinary Counsel to be deemed conclusively established for all purposes. The Court finds that Felipe Juarez is resigning in lieu of discipline. The Court, being advised that the acceptance of the resignation is in the best interests of the public and the profession, hereby concludes that the following Order is appropriate.

IT IS ORDERED that the law license of Felipe Juarez of Austin, Texas, State Bar Card Number 11041000, which was previously issued by this Court, be canceled and his name be dropped and deleted from the list of persons licensed to practice law in Texas.

IT IS FURTHER ORDERED that Felipe Juarez immediately surrender his State Bar Card and Texas law license to the Clerk of the Supreme Court of Texas or file with the Court an affidavit stating the cause of his inability to do so.

IT IS FURTHER ORDERED that Felipe Juarez is permanently enjoined and prohibited from practicing law in the State of Texas, holding himself out as an attorney at law, performing legal services for others, giving legal advice to others, accepting any fee directly or indirectly for legal services, appearing as counsel or in any representative capacity in any proceeding in any Texas court or before any Texas administrative body (whether state, county, municipal, or other), or holding himself out to others or using his name in any manner in conjunction with the words "Attorney at Law", "Counselor at Law", or "Lawyer".

It is further **ORDERED** that Felipe Juarez shall immediately notify each of his current clients in writing of this resignation. In addition to such notification, Felipe Juarez is **ORDERED** to return any files, papers, unearned fees and other property belonging to clients and former clients in his possession to the respective clients or former clients or to another attorney at the client's or former client's request. Felipe Juarez is **ORDERED** to file with the Chief Disciplinary Counsel, 400 West 15th Street, Suite 1500, Austin, Texas 78701, within thirty (30) days of the effective date of this Order an affidavit stating that all current clients have been notified of his resignation and that all files, papers, monies and other property belonging to all clients and former clients have been returned as ordered herein.

It is further **ORDERED** that Felipe Juarez shall, within thirty (30) days after the date on which this Order is signed by the Court, notify in writing each and every justice of the peace, judge, magistrate, and chief justice of each and every court in which Felipe Juarez has any matter pending of the terms of this Order, the style and cause number of the pending matter(s), and the

Felipe Juarez is ORDERED to file with the State Bar of Texas, 400 West 15th Street, Suite 1500, Austin, Texas 78701, within thirty (30) days of the date of the effective date of this Order an affidavit stating that he has notified in writing each and every justice of the peace, judge, magistrate, and chief justice of each and every court in which he has any matter pending of the terms of this Order, the style and cause number of the pending matter(s), and the name, address and telephone number of the client(s) he is representing in Court.

#### TO THE HONORABLE SUPREME COURT OF TEXAS:

Pursuant to Part X of the Texas Rules of Disciplinary Procedure, Dawn Miller, Acting Interim Chief Disciplinary Counsel, hereby files a response on behalf of the State Bar of Texas, acting by and through the Commission for Lawyer Discipline, to the Motion for Acceptance of Resignation in Lieu of Discipline of Felipe Juarez dated on August 25, 1999.

I.

The acceptance of the resignation of Felipe Juarez, State Bar Card No.11041000, is the best interests of the public and the profession.

The professional misconduct with which Felipe Juarez (hereafter called 'Juarez'), is charged is as follows:

II.

#### The State Bar of Texas Compliant - A0079904067

On January 27, 1994, Juarez was placed on five(5) years' disciplinary probation by Judgment and Order of the 200<sup>th</sup> Judicial District Court of Travis County in Cause No. 93-03609. Juarez's probation was subsequently revoked by the Court for having engaged in conduct constituting professional misconduct while on said probation by Order dated March 15, 1999. While under disciplinary suspension on July 1, 1999, Juarez was

in the 201st Judicial District Court with attorney Melvin E.

Corley who had taken over a case from Juarez concerning a Motion to Compel. The Court determined that Juarez was suspended and discussed this matter with Juarez. Juarez determined what attorney should handle his client's matter without discussing it with the client and the attorney appeared with Juarez in court. It was at this point that the client was asked by the Judge if the client wanted the attorney to represent him. Juarez admitted that he had not notified the client of his suspension as ordered by the Probation Order nor in compliance with the Order of Revocation.

By Juarez appearance in court and failings to comply with the conditions of the Order, he has violated the Texas Disciplinary Rules of Professional Conduct.

III.

WHEREFORE, the State Bar of Texas, moves the Court to accept the resignation in lieu of discipline and grant the motion filed by Movant.
