DISCIPLINARY PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, Robert C.E. Wolfe. (hereinafter called "Respondent"), showing the Court:

I.

Discovery Control Plan

Pursuant to Rules 190.1 and 190.2, TEXAS RULES OF CIVIL PROCEDURE (TRCP), Petitioner intends discovery in this case to be conducted under the Level II Discovery Control Plan.

II.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001. et seq. (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

III.

Respondent is an attorney licensed to practice law in Texas and is a member of the State Bar of Texas. Respondent is a resident of and has her principal place of practice in Dallas County,

Texas. An officer may serve citation on Respondent's attorney. L. Vance Stanton, at 8330 Meadow Road. Suite 226, Dallas, Texas 75231.

IV.

In or around September of 1997, Respondent was employed to represent L.R. Stow's ("Stow") ex-wife in a post-divorce matter. A mediation occurred on or about January 21, 1998, at the offices of R.B. Pool in Dallas. A proposed Mediation Settlement Agreement was prepared and distributed to the attorneys at or near the conclusion of the mediation session. Thereafter, upon request from Stow's attorney, the mediator sent Stow's attorney a copy of the Mediation Settlement Agreement, which did not include the changes made by Respondent and Respondent's client after the mediator left his office.

V.

Respondent and Stow's attorney communicated in order to draft an agreement. Respondent worked from the copy of changes made by her and her client, while Stow's attorney worked from the copy provided by the mediator. Respondent failed to provide Stow's attorney with a copy of the agreement before she filed it with the court. As a result, the agreement Respondent filed with the court contained provisions which neither Stow nor his attorney had agreed.

VI.

Stow's attorney communicated with Respondent on several occasions in an attempt to have the Medication Settlement Agreement corrected to delete the changes made by Respondent and Respondent's client after the mediator left his office, which were not approved by Stow and his

attorney. Respondent refused to delete the changes made in the Mediation Settlement Agreement which were made by Respondent and Respondent's client after the mediator left his office, and which were not approved by Stow and his attorney. As a result. Stow was required to hire additional counsel to prosecute Stow's Motion to Sign Orders on Mediation Settlement Agreement and Motion to Strike and Motion for Sanctions. Stow's new attorney noticed Respondent for deposition. On or about April 17, 1998, the day Respondent's deposition was to be taken. Respondent entered into an agreement correcting the Mediation Settlement Agreement.

VII.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs IV, V, VI, hereinabove, which occurred on or after January 1, 1990, constitute conduct which violates Rule 3.02 of the Texas Disciplinary Rules of Professional Conduct.

VIII.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by L.R. Stow filing a complaint on or about August 4, 1998.

PRAYER

WHEREFORE, PREMISES CONSIDERED. Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
