### REPORTS AND ACTION ITEMS

## Report of Specialty Courts Advisory Council on Specialty Court Best Practices

Ms. Camille Cain, Executive Director, Criminal Justice Division, Office of the Governor, reported that Texas Government Code Section 121.002 requires Specialty Court Best Practices recommended by the Specialty Courts Advisory Council ("SCAC") under Section 772.0061(b)(2) to be approved by the Council. After review of the *Adult Drug Court Best Practice Standards* (Volumes 1 & II and the specified Key Components) ("Standards") developed by the National Association of Drug Court Programs ("NADCP"), the SCAC recommended that the Council adopt NADCP's Standards as best practice standards for Texas Specialty Court Programs and requests the consideration and approval of the Council.

The Office of Court Administration will work with the Criminal Justice Division to provide the Council with the Standards for consideration at a future meeting.

## **Texas Indigent Defense Commission Report**

Presiding Judge Sharon Keller reported on Hidalgo County compliance issues and the <u>Texas Indigent Defense Commission</u>'s ("Commission") decision to withhold funding while they work towards an agreement. She also reported that the Commission awarded a Technical Support Grant to Harris County to coordinate a statewide effort to provide case review and assistance to defendants anywhere in Texas in response to recent changes in the protocol for analysis and reporting of mixed DNA evidence. Also, the Commission issued three publications; an updated publication on <u>Fair Defense Laws</u>, a publication on <u>Indigent Defense Mentoring in Texas: A Guide to Establishing a Mentorship Program</u>, and the Commission's <u>Annual and Expenditure Report Fiscal Year 2015</u>.

Mr. Edwin Colfax, Commission Grant Program Manager, presented highlights from the Annual and Expenditure Report.

Mr. Rick Figueroa provided an <u>overview</u> of the Shared Solutions proposal, *The Pathway to Becoming a Judicial Center of Excellence*, after which he requested a motion for approval. The proposal was approved by acclamation.

## Report on Timothy Cole Exoneration Review Commission

Exoneration Commission staff members, Ms. Terri Peirce and Ms. Alejandra Pena, provided a <u>presentation</u> on the progress of the <u>Timothy Cole Exoneration Review Commission</u>. The next meeting of the Exoneration Commission is scheduled for March 22, 2016.

## Elders Committee

Mr. Jeff Rinard, OCA Certification Division Director, provided an <u>overview</u> of the Guardianship Compliance Project. He informed the Council of the implementation award to receive technical assistance to implement the Conservatorship Accountability Project. The grant was received through the National Center for State Courts.

## <u>Criminal Justice Committee Update</u>

Judge Kelly Moore, Chairman of the Criminal Justice Committee, advised that the Committee met on February 25 and heard presentations on pretrial models from Kentucky and Harris County. The Committee also received an update from Texas A&M University's Public Policy Research Institute on the progress of their research as well as an update from the Pretrial Advisory Committee. Judge Moore said the Committee plans to bring recommendations to the Council at its meeting in August.

#### Courthouse and Judicial Security Survey

Mr. Slayton reported on the courthouse and judicial security survey results.

#### **NEW BUSINESS**

### Consider appointment of Judicial and Courthouse Security Committee

Chief Justice Hecht assigned members to a newly-formed Judicial and Courthouse Security Committee: Justice Bill Boyce, Judge Valencia Nash, Judge Glenn Phillips, Senator Judith Zaffirini, and Mr. Carlos Amaral. Judge Scott Jenkins will chair the Committee.

Additionally, Representative Murr offered HB 2241 last year relating to the carrying of concealed handguns by certain county officers and employees in a courthouse and requested that the committee study that issue if appropriate.

With motion by Chief Justice Radack and second by Mr. Amaral, creation of the Committee was approved by acclamation.

## <u>Consider setting salary of the regional presiding judges for the 2016-2017 biennium pursuant to Texas Government Code Sec. 74.051</u>

OCA General Counsel, Ms. Mena Ramon, requested approval for setting the <u>salary of the</u> <u>regional presiding judges</u> for the 2016-2017 biennium. After proper motion and second, the request was approved by acclamation.

# Consider amendments to the Texas Judicial Council Reporting Requirements and authorize notice in the Texas Register

Ms. Angela Garcia requested approval for notice to adopt and publish amendments to the Texas Judicial Council <u>reporting requirements</u> in the Texas Register. With a motion by Judge Spencer and a second from Mr. Figueroa, the request was approved by acclamation.
