Minutes from Previous Meeting

a. Elections- Martha Jamison

Mr. Trabulsi introduced the Texans for Lawsuit Reform and Texas Civil Justice League represented and presented their detailed joint proposal for judicial selection.

The proposal included:

- 1. Appointment of judges by the Governor to all state courts for a term of 12 years.
- 2. Review of nominees by an impartial, bipartisan and diverse advisory panel that would include lawyers, non-lawyers, and House members to review and evaluate the nominations rating them as unqualified, qualified, or highly qualified.
- 3. Confirmation of nominees by a majority of Senate.
- 4. Ratification vote by the people within a few years of assuming office.
- 5. Enhanced qualifications for judicial office.
- 6. Clarify and enhance various methods for removing judges.

The Commissioners asked questions, made comments, and expressed concerns with the proposal, including diversity, qualification requirements, and the role of the House of Representatives in the proposal.

Chairman Beck stressed the importance of reaching out to the public for their view, and requested that several members of the Commission attend each such meeting.
