# Presentation on Remote Proceedings During the Pandemic

Judge Antonia Arteaga, 57<sup>th</sup> District Court, Bexar County, Judge Emily Miskel, 470<sup>th</sup> District Court, Collin County, Judge Karen Crump, 250<sup>th</sup> District Court, Travis County, and Judge Roy Ferguson, 394<sup>th</sup> District Court, Brewster County, presented on their experience with remote proceedings and virtual jury trials during the pandemic: specifically noting how remote proceedings have worked for every type of case and every type of proceeding; how it has improved participation in terms of parties and how parties are able to participate; how virtual jury trials have worked in terms of jury participation and how attorneys, judges, litigants feel about them; and how courts can and should use them going forward.
