

Change in Cases Added, FY 20 to 21











New civil case filings continued to decline at every trial court level except for district.






Filings increased in some case categories.




Justice and Municipal Courts





After reaching an all-time high in 2019, new landlord/tenant cases filed in justice courts fell 28 percent in 2020 and another 31 percent in 2021. The number of cases filed in 2021 was the lowest since 2000.



Debt cases continued to decline in the district and county courts but grew to an all-time high in the justice courts.







Estate cases and involuntary mental health commitments were 2 of the few categories in which filings increased during the pandemic.








New family cases increased while post-judgment suits for modification or enforcement continued to decline.






Filings decreased in half of case categories, but the most significant declines occurred in child support (IV-D) modification or enforcement cases.











New divorce cases and new parent-child cases not involving divorce increased from the previous year.

New child protection cases fell for the third year in a row to the lowest level since 2014.








Juvenile






Since the peak in 2007, the number of juvenile cases filed has fallen 74 percent to the lowest level since 1993. For the second consecutive year, new delinquent conduct cases involving a felony offense exceeded those involving a misdemeanor.









Filings declined in all categories except for homicides in 2021, with the largest declines in assault and burglary cases.







Cases involving juveniles or minors that were filed in justice and municipal courts declined in 2021. Filings declined 72 percent since 2012.









The number of new misdemeanor cases has been falling since 2007. The number of new felony cases reached an all-time high in 2019, declined in 2020 due to the pandemic but rebounded in 2021.






Over the last 5 years the only **misdemeanor** case types that have increased are assault cases and first DWI offenses.







The steepest declines in **felony** cases occurred in drug cases and cases involving indecency or sexual assault of a child.

Aside from capital murder, aggravated assault/attempted murder, family violence, and auto theft were the only felony categories that increased in 2021.






New misdemeanor drug offense cases fell by almost half in 2020 due to continued decline in the prosecution of marijuana cases as well as an overall steep decrease in filed misdemeanor cases due to the pandemic. Unlike misdemeanor offenses, felony drug offenses increased in 2021.





Traffic and parking cases continued a 13-year decline that was intensified by the pandemic. 2021 filings were 59 percent lower than the peak in 2006 and was the lowest number since 1980. In 2021, non-traffic fine only misdemeanor cases were 64 percent lower than the peak number of filings in 2008 and was the second lowest number since 1979.




Appellate






The number of criminal filings in the **Courts of Appeals** was the lowest since 1988. After the highest civil filing rate in the history of the courts of appeals in 2019, the number of civil cases declined during the pandemic.






In the **Court of Criminal Appeals**, applications for writs of habeas corpus declined to the lowest level since at least 2001. After declining during the previous year to the lowest level since at least 1989, petitions for discretionary review increased in 2021. Original proceedings declined to the lowest level since 1999.





Petitions for review, which account for the majority of the **Supreme Court**'s caseload, declined for the second year in a row. Regular causes declined as well, while the number of other petitions and writs increased.








Clearance Rates and Pending Caseload




Clearance Rates in Trial Court Case Types

March 1, 2020 to December 31, 2021






Active Pending Criminal Cases as of December 31






Active Pending Civil Cases as of December 31




Active Pending Family Cases as of December 31





