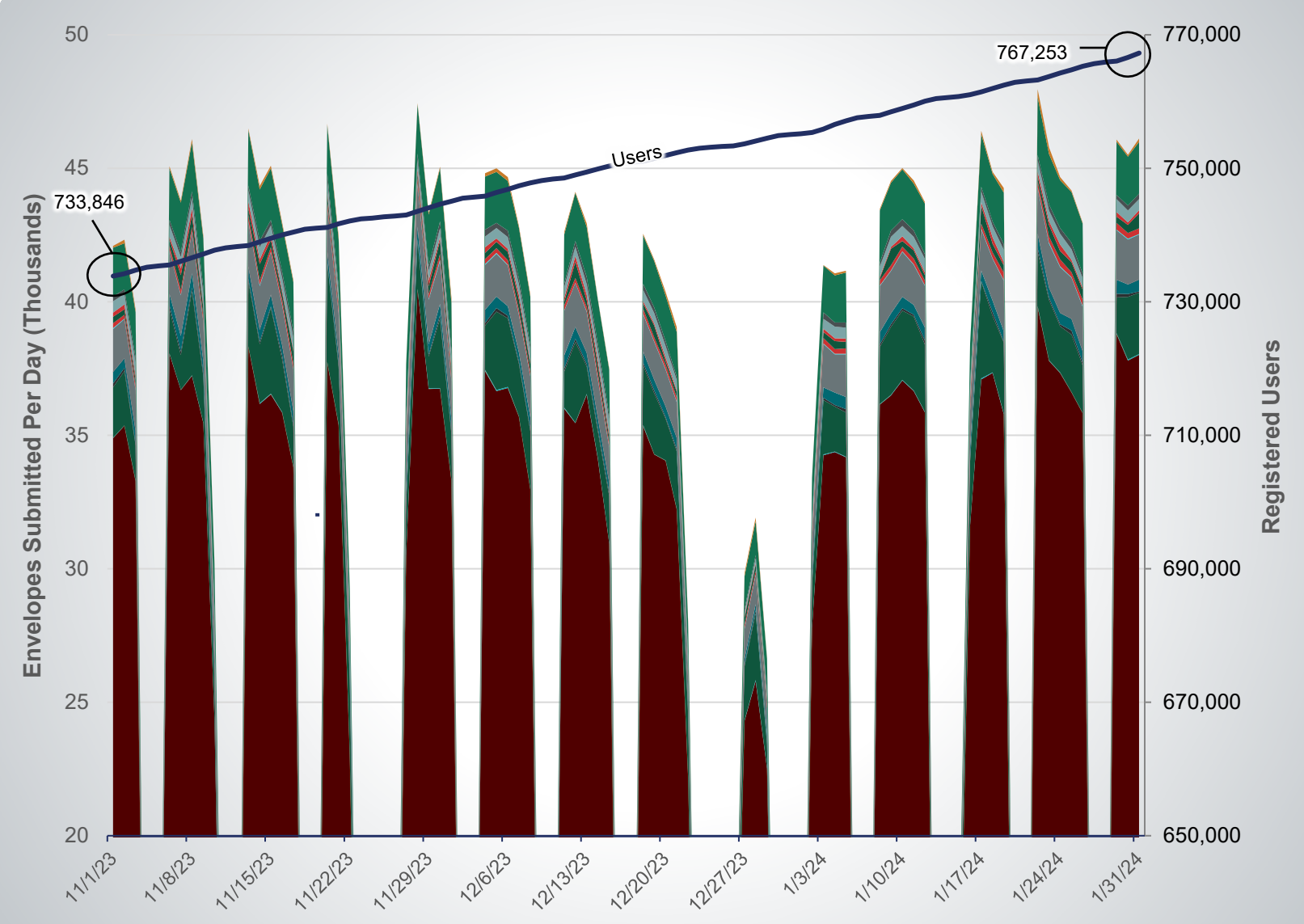

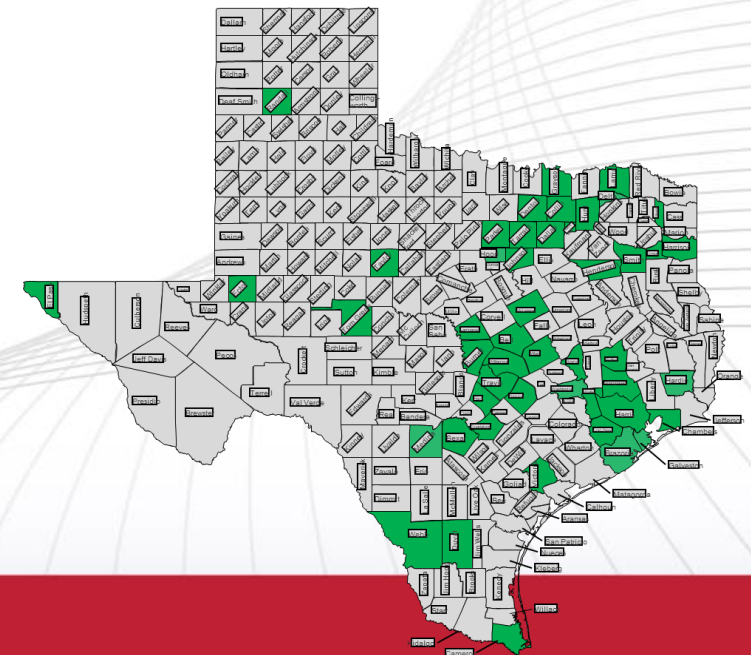


Program Continues to Thrive

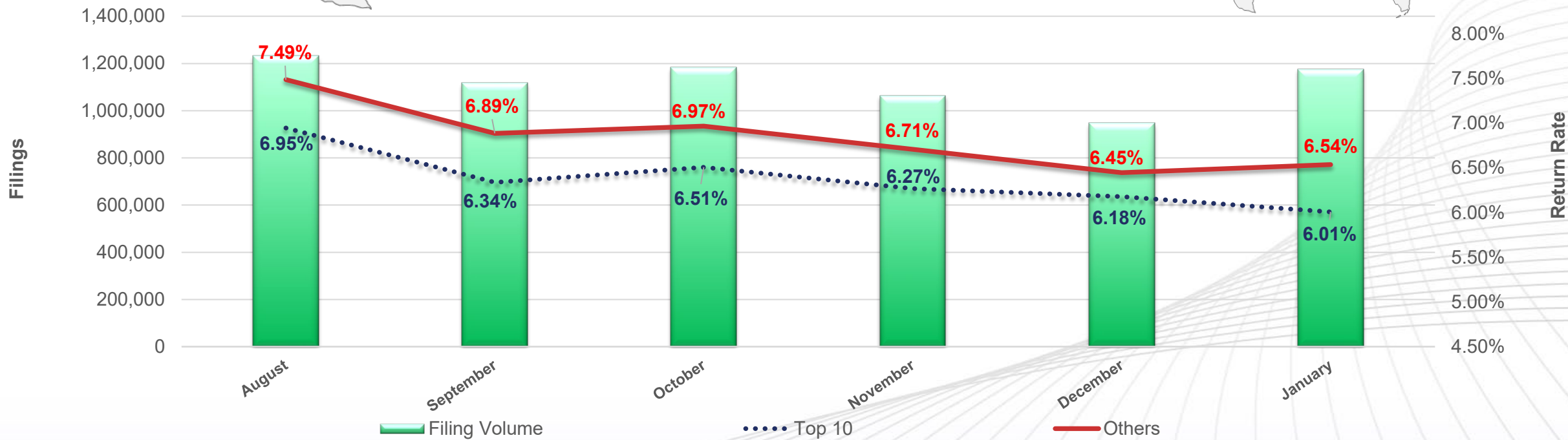
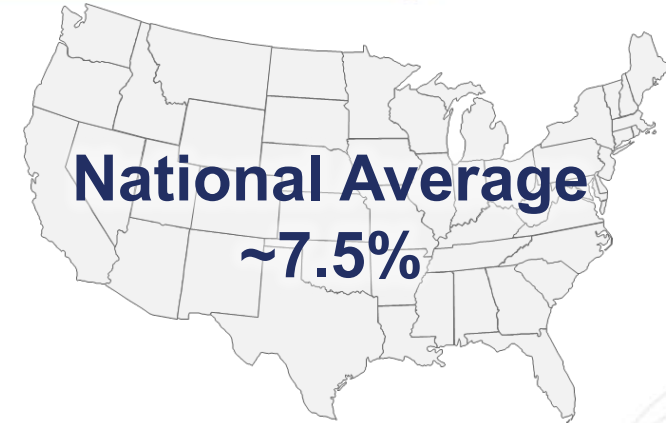
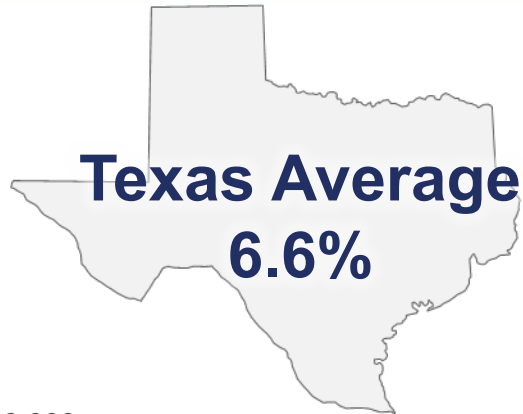
- 767k+ user accounts created to date

- State-provided filing portal still manages ~80% of the filing volume across the state

 - 21 out of "Top 22" counties live with one or more JP precinct
- 7 active/pending engagements



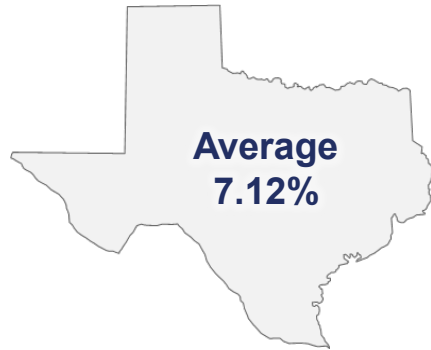
Return for Correction Rates – Market Comparison

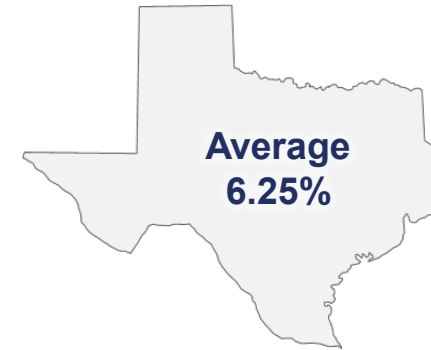

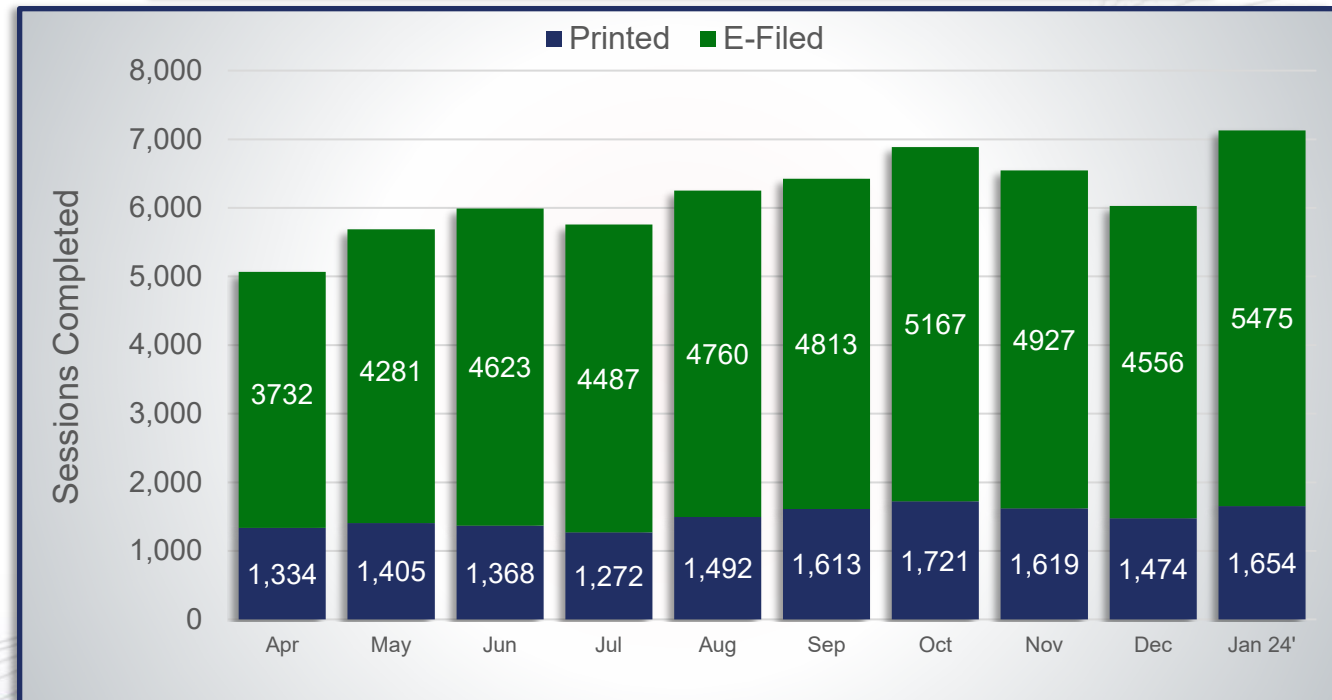
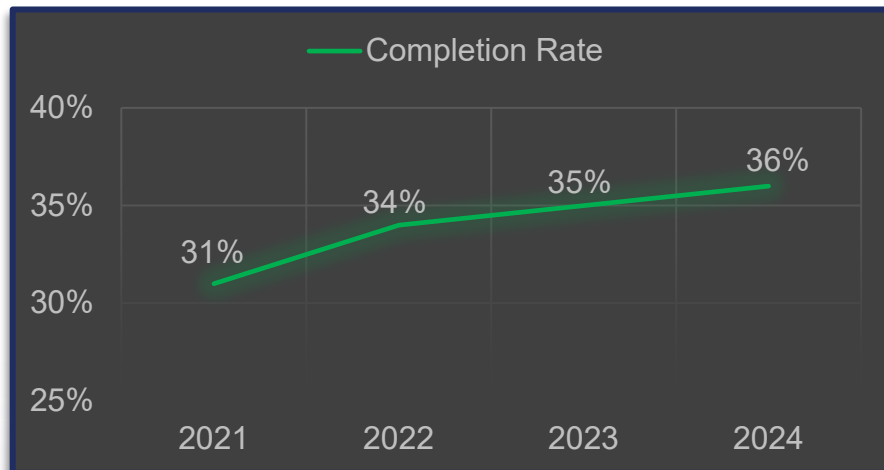


Summary

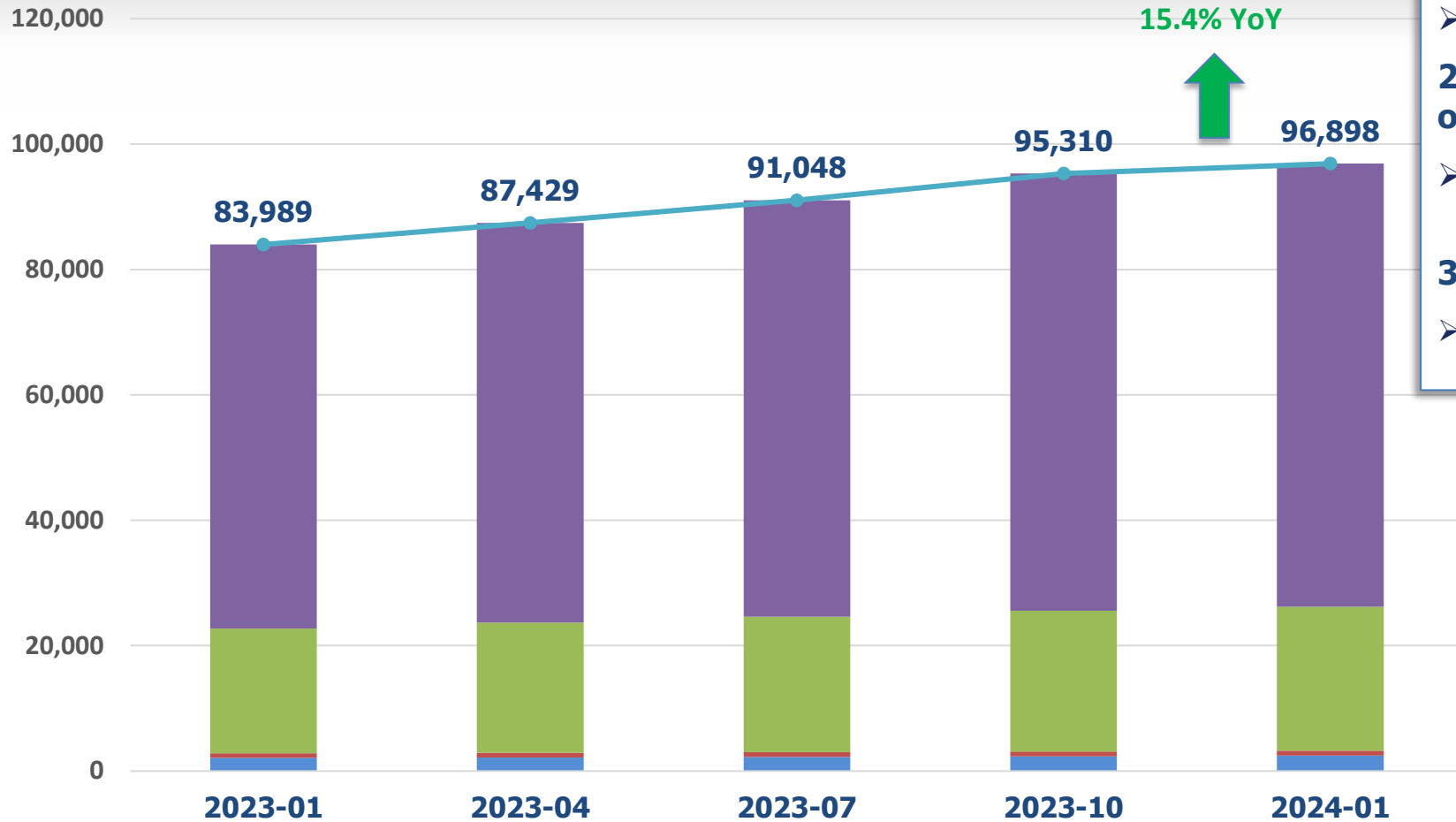
- **45 interviews** currently available across Texas

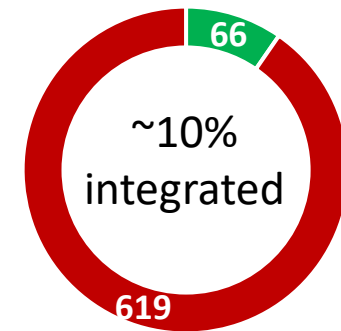

Doc Purchase Revenue in 2023

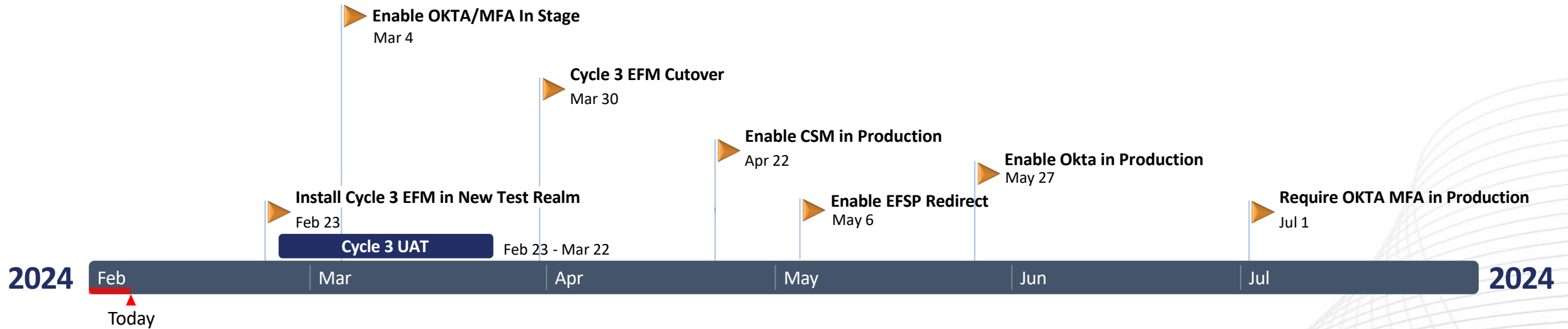
