ORDER

On this the 7th day of June, 2016, came on to be heard the MARGARET ANNE MORALES' Motion to declare Plaintiff, ANTHONY C. AGUILAR, A VEXATIOUS LITIGANT AND REQUIRING SECURITY FOR COSTS AND MOTION FOR A PREFILING ORDER. The matter was called, and although all parties received proper notice of the setting of said motion for hearing, ANTHONY AGUILAR and MICHAEL AGUILAR wholly failed to appear.

The Court, after hearing the evidence and argument of counsel, finds that a) there is no reasonable probability that ANTHONY C. AGUILAR will prevail in his Counterclaim and Third Party Claim; b) that ANTHONY C. AGUILAR has, since 2012, commenced, prosecuted or maintained at least five litigations as a pro se litigant in a court other than a small claims court, that have been determined adversely to Aguilar, remained pending for at least two years without having been brought to trial or hearing, or determined by a trial or appellate court to be frivolous or groundless under state laws or rules of procedure; and c) that ANTHONY C. AGUILAR has, after litigation has been finally determined against him, repeatedly relitigated or attempted to relitigate, pro se, the validity of the determination against him or the cause of action, claim or controversy against the same Defendant, namely MARGARET ANNE MORALES.

ACCORDINGLY, IT IS ORDERED, ADJUDGED AND DECREED that ANTHONY C. AGUILAR is hereby declared to be a vexatious litigant.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED, that ANTHONY C. AGUILAR shall furnish security for MARGARET ANNE MORALES' reasonable expenses, including costs and attorney's fees to be incurred in defense of ANTHONY C. AGUILAR'S Counterclaim and Third Party Claim, in the amount of \$ 175,000., which security shall be by surety bond filed with the Bexar County Clerk, or cash deposited with the registry of the County Clerk, to be tendered to the County Clerk of Bexar County on or before June 21, 2016.

FINALLY, IT IS ORDERED, ADJUDGED AND DECREED that Aguilar be and hereby is prohibited from filing, in propia persona, any new litigation in any court in this State of Texas, without first securing the permission of the local administrative judge of the court in which he intends to file same.

All other relief requested, be and hereby is DENIED.

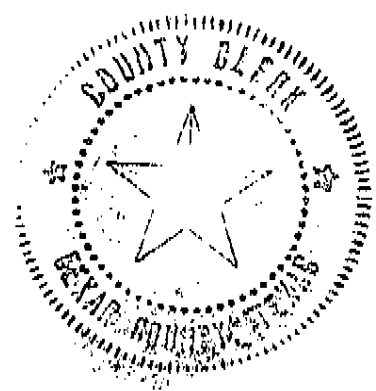
