ORDER DECLARING GLENN WINNINGHAM FEARN A VEXATIOUS LITIGANT,  
STAYING THE LITIGATION, AND REQUIRING SECURITY


---

On June 23, 2020, this Court considered on written submission the following motions (and all attached or incorporated evidence):

1. Defendants Sharen Wilson’s and The Tarrant County Sheriff’s Office’s Motion to Dismiss and to Declare Plaintiff a Vexatious Litigant.

2. Euless Defendants’ Supplemental Joinder to Defendant Wilson’s Vexatious Litigant Motion (collectively “the Motions to Dismiss”). The Court also considered the pleadings on file and the documents Plaintiff Glenn Winningham Fearn has filed in response to the Motions to Dismiss. After considering the foregoing, the Court GRANTS the Motions to Dismiss on the grounds asserted under Texas Civil Practice and Remedies Code Chapter 11.

The Court FINDS that all the notices and time deadlines required by the Texas Civil Practice and Remedies Code Chapter 11 have been met or exceeded in this matter. The Court further FINDS that Glenn Winningham Fearn meets the criteria established by the Texas Civil Practice and Remedies Code Chapter 11 for him to be declared a vexatious litigant.

IT IS, THEREFORE, ORDERED, ADJUDGED, AND DECREED that Glenn Winningham Fearn is hereby declared to be a vexatious litigant for all purposes.

IT IS FURTHER ORDERED that proceedings in this matter are hereby stayed; that Glenn Winningham Fearn is ORDERED to provide security to Defendants Sharen Wilson, Tarrant County Sheriff's Office, Timothy C. Graham, Edgar L. Hurtado, Michael R. Collingwood, Michael Brown, Lacy Britton, Stacy White, Echols-Kirksey, V. Nilson, and Linda Martin by posting a bond with this Court in the amount of \$ 1 000<sup>00</sup> (One thousand United States Dollars) to cover reasonable expenses incurred in or in connection connection with the litigation commenced by Glenn Winningham Fearn including costs and attorney fees; that, if Glenn Winningham Fearn fails to post said bond with the Court within 30 calendar days of the signing of this Order, then this suit will be dismissed with prejudice in its entirety pursuant to section 11.056 of the Texas Civil Practice and Remedies Code without further notice to Fearn.

IT IS FURTHER ORDERED that Glenn Winningham Fearn is prohibited from filing, *in propria persona*, any new litigation in a court in this State without the written permission of a local administrative judge in the jurisdiction where he attempts to file such litigation. The local administrative judge may condition pre-filing permission on the furnishing of security for the benefit of defendant(s) or other conditions as provided by Chapter 11 of the Texas Civil Practice and Remedies Code.

IT IS FURTHER ORDERED that if Glenn Winningham Fearn violates this pre-filing Order, he will be subject to contempt of court, in addition to the other remedies provided by the Texas Civil Practice and Remedies Code.

IT IS FURTHER ORDERED that the Clerk of the Court is directed to notify the Office of Court Administration of the Texas Judicial System ("OCA") of this Court's declaration of Glenn Winningham Fearn as a vexatious litigant by delivering a copy of this order to OCA, which can be made at the following contact address:
