**ORDER GRANTING MOTION TO DEEM WANDA LEE BOWLING F/N/A WANDA LEE DAHLHEIMER A VEXATIOUS LITIGANT**

On this day, this Court considered Lester John Dahlheimer Jr.'s Motion to Deem Wanda Lee Bowling f/n/a Wanda Lee Dahlheimer a Vexatious Litigant, Require Security from Bowling, and to Dismiss Bowling's Claims with Prejudice in the Absence of Security. After hearing on same, this Court finds and is of the opinion that the Motion should be granted. It is therefore,

ORDERED that Lester John Dahlheimer Jr.'s Motion to Deem Wanda Lee Bowling f/n/a Wanda Lee Dahlheimer a Vexatious Litigant, Require Security from Bowling, and to Dismiss Bowling's Claims with Prejudice in the Absence of Security is GRANTED. It is further,

ORDERED that Wanda Lee Bowling f/n/a Wanda Lee Dahlheimer is hereby deemed VEXATIOUS LITIGANT pursuant to Chapter 11 of the Texas Civil Practice and Remedies Code. It is further,

ORDERED that Wanda Lee Bowling f/n/a Wanda Lee Dahlheimer post security with this Court in the amount of \$ 25,000 ~~no later than~~ 2020 **PRIOR TO FILING DOCUMENTS WITH THE COLLIN COUNTY CLERK.**

IT IS FURTHER ORDERED that Wanda Lee Bowling f/n/a Wanda Lee Dahlheimer post an additional \$ 10,000 for any appeal. It is further,

ORDERED that Wanda Lee Bowling f/n/a Wanda Lee Dahlheimer is hereby prohibited from filing new litigation in federal or state court of the State of Texas, subject to her meeting

the conditions set out in Chapter 11 of the Texas Civil Practice & Remedies Code prior to filing new litigation. It is further,

ORDERED that upon entry of this Order, the Clerk of this Court shall send copy of this Order to the Office of Court Administration of the Texas Judicial System. It is further,

ORDERED that should Wanda Lee Bowling f/n/a Wanda Lee Dahlheimer fail to post security in the full amount as required by this Order by the date set out herein, this current lawsuit shall be DISMISSED WITH PREJUDICE with all costs to be taxed to Wanda Lee Bowling f/n/a Wanda Lee Dahlheimer.
