ORDER APPOINTING A TASK FORCE FOR PROCEDURAL RULES IN SUITS AFFECTING THE PARENT-CHILD RELATIONSHIP FILED BY A GOVERNMENTAL ENTITY

ORDERED that:

House Bill 7, enacted by the 85th Legislature, directs the Court to make procedural rules for cases governed by Chapter 263 of the Family Code that address:

- (1) conflicts between the filing of a motion for new trial and the filing of an appeal of a final under rendered under this chapter; and
- (2) the period, including an extension of at least 20 days, for a court reporter to submit the reporter's record of a trial to an appellate court following a final order rendered under this chapter.

Act of May 30, 2017, 85th Leg., R.S., ch. 317, § 30 (H.B. 7) (to be codified at TEX. FAM. CODE § 263.4055).

A task force is appointed to advise the Court on the rules required by House Bill 7. The task force should make any other recommendations to the Court that the task force deems appropriate to expedite and improve the trial and appeal of cases governed by Chapter 263. In formulating its recommendations, the task force should be guided by the principle that proceedings under Chapter 263 should be expedited to minimize disruption and confusion in the lives of children and parents without precluding full consideration of the issues and their just and fair resolution.
