## ORDER DECLARING DRUE ALLEN HOLLIS A VEXATIOUS LITIGANT, STAYING THE LITIGATION, AND REQUIRING SECURITY

On February 7, 2019, this Court considered the following seven motions (and all attached or incorporated evidence):

- 1. Defendants Probate Court No. 1 of Tarrant County and Probate Court No. 2 of Tarrant County's Motion to Dismiss and to Declare Plaintiff a Vexatious Litigant;
- 2. Defendant Tarrant County Sheriff Bill E. Waybourn's Motion to Dismiss and to Declare Plaintiff a Vexatious Litigant;
- 3. Defendant Tarrant County Hospital District d/b/a JPS Health Network's Joinder in Defendants Probate Court No. 1 of Tarrant County and Probate Court No. 2 of Tarrant County's Motion to Dismiss and to Declare Plaintiff a Vexatious Litigant;
- 4. Defendant Acclaim Physician Group, Inc.'s Joinder in Defendants Probate Court No. 1 of Tarrant County and Probate Court No. 2 of Tarrant County's Motion to Dismiss;

- 5. Defendant University of North Texas Health Science Center's Joinder in Defendants Probate Court No. 1 of Tarrant County and Probate Court No. 2 of Tarrant County's Motion to Dismiss and to Declare Plaintiff a Vexatious Litigant;
- 6. Defendant Mesa Springs, LLC's Joinder in Defendants Probate Court No. 1 of Tarrant County and Probate Court No. 2 of Tarrant County's Motion to Dismiss and to Declare Plaintiff a Vexatious Litigant;
- 7. Defendant Propath Associates, P.L.L.C.'s Joinder in Defendants Probate Court No. 1 of Tarrant County and Probate Court No. 2 of Tarrant County's Motion to Dismiss and to Declare Plaintiff a Vexatious Litigant

(collectively "the Motions to Dismiss"). The Court also considered the pleadings on file; the documents Plaintiff Drue Allen Hollis has filed in response to the Motions to Dismiss; and the arguments of Defendants' counsel and Drue Allen Hollis, appearing pro se. After considering the foregoing, the Court GRANTS the Motions to Dismiss on the grounds asserted under Texas Civil Practice and Remedies Code Chapter 11.

The Court FINDS that all the notices and time deadlines required by the Texas Civil Practice and Remedies Code Chapter 11 have been met or exceeded in this matter. The Court further FINDS that Drue Allen Hollis meets the criteria established by the Texas Civil Practice and Remedies Code Chapter 11 for him to be declared a vexatious litigant.

IT IS, THEREFORE, ORDERED, ADJUDGED, AND DECREED that Drue Allen Hollis is hereby declared to be a vexatious litigant for all purposes.

IT IS FURTHER ORDERED that proceedings in this matter are hereby stayed; that Drue Allen Hollis is ORDERED to provide security to Defendants Probate Court No. 1 of Tarrant County; Probate Court No. 2 of Tarrant County; Tarrant County Sheriff Bill E. Waybourn; Tarrant County Hospital District d/b/a JPS Health Network; Acclaim Physician Group, Inc.; University of North Texas Health Science Center; Mesa Springs, LLC; and

Propath Associates, P.L.L.C. by posting a bond with this Court in the amount of \$\frac{7,000.00}{2}\$ to cover reasonable expenses incurred in or in connection connection with the litigation commenced by Drue Allen Hollis including costs and attorney fees; that, if Drue Allen Hollis fails to post said bond with the Court within 30 calendar days of the signing of this Order, then this suit will be dismissed with prejudice in its entirety pursuant to section 11.056 of the Texas Civil Practice and Remedies Code without further notice to Hollis.

IT IS FURTHER ORDERED that Drue Allen Hollis is prohibited from filing, in propria persona, any new litigation in a court in this State without the written permission of a local administrative judge in the jurisdiction where he attempts to file such litigation. The local administrative judge may condition prefiling permission on the furnishing of security for the benefit of defendant(s) or other conditions as provided by Chapter 11 of the Texas Civil Practice and Remedies Code.

IT IS FURTHER ORDERED that if Drue Allen Hollis violates this prefiling Order, he will be subject to contempt of court, in addition to the other remedies provided by the Texas Civil Practice and Remedies Code.

IT IS FURTHER ORDERED that the Clerk of the Court is directed to notify the Office of Court Administration of the Texas Judicial System ("OCA") of this Court's declaration of Drue Allen Hollis as a vexatious litigant by delivering a copy of this order to OCA, which can be made at the following contact address:

IT IS FURTHER ORDERED because the Court has granted the Motions to Dismiss on the grounds asserted under Texas Civil Practice and Remedies Code Chapter 11, the Court does not reach any grounds for dismissal asserted in the Motions to Dismiss under Texas Rule of Civil Procedure 91a, which are DEEMED MOOT.
