**ORDER GRANTING MOTION TO DECLARE VALENTINA SPASSOVA  
A VEXATIOUS LITIGANT**

On this day, the Court considered the verified Joint Motion to Declare Valentina Spassova a Vexatious Litigant and Application for Temporary Restraining Order and Permanent Injunction (hereinafter referred to as the "Motion"), filed by W. Cameron McCulloch, in his capacity as the Court appointed and duly qualified Guardian of the Estate of Lily Alexandra Sheshtawy, a Minor, and Nader Sheshtawy and Hanya Sustache, in their capacities as the Independent Co-Administrators of the Estate of Adel Sheshtawy, Deceased (hereinafter referred to collectively as the "Movants"). After consideration of the Joint Motion to Declare Valentina Spassova a Vexatious Litigant, the Response, if any, and the arguments of counsel, if any, the Court is of the opinion and finds that Movant's Motion should be **GRANTED** in all respects. The Court finds and declares that Valentina Spassova is a vexatious litigant and, as such, it is therefore:

ORDERED, ADJUDGED, and DECREED that Valentina Spassova shall furnish security for the benefit of the Movants, by posting a surety bond with the court clerk in the amount of \$ 5,600<sup>00</sup> by July 15, 2015. The security is to assure payment to the Movants for reasonable expenses, including the Movants' court costs and attorney's fees. It is further,

ORDERED, ADJUDGED, and DECREED that if Valentina Spassova does not furnish security within the time limit set by this order, the Court will dismiss all claims filed by


Valentina Spassova in the above numbered and styled cause with prejudice against Valentina Spassova. It is further,

ORDERED, ADJUDGED, and DECREED that all claims filed by Valentina Spassova in the above numbered and styled cause are hereby abated until Valentina Spassova complies with this Order or until the matter is dismissed by further order of this Court. It is further,

ORDERED, ADJUDGED, and DECREED that Valentina Spassova shall not file, as a pro se party, any new litigation in a court in Texas against W. Cameron McCulloch, in any capacity, Nader Sheshtawy, in any capacity, Hanya Sustache, in any capacity, Michael Fuqua, in any capacity, and/or their respective agents, directors, officers, employees, heirs, assigns, attorneys, and/or representatives, without first obtaining permission from the appropriate local administrative judge as required by Texas Civil Practice and Remedies Code Section 11.102(a). It is further,

ORDERED, ADJUDGED, and DECREED that, as required by Texas Civil Practice and Remedies Code Section 11.104, the court clerk shall provide a copy of this Order to the Office of Court Administration of the Texas Judicial System.
