BE IT REMEMBERED that on this day came to be considered **Defendant's Motion to Declare Plaintiff as a Vexatious Litigant**. After considering the pleadings of the parties filed herein and the argument of counsel, the Court is of the opinion that the motion is meritorious and that the following order should issue:

It is hereby ORDERED that said Motion is GRANTED. Plaintiff Richard Payne, TDCJ-CID No. 620984, is hereby DETERMINED TO BE A VEXATIOUS LITIGANT.

THEREFORE, Plaintiff is ordered to furnish security in the amount of \$ 500.⁰⁰. The amount must be furnished to the Court by October 17, 2011. Should Plaintiff fail to furnish such security within the time set by this Order, the above referenced and numbered cause is DISMISSED.

It is also FURTHER ORDERED that pursuant to Section 11.101 of the Texas Civil Practice and Remedies Code, Plaintiff Richard Payne, TDCJ-CID No. 620984 is hereby prohibited from filing, in propria persona, a new litigation in a court in the State of Texas without first obtaining approval of a local administrative judge.

It is also FURTHER ORDERED that the Clerk of the Court shall forward a copy of this Order to the Office of Court Administration of the Texas Judicial System in accordance with Section 11.104(a) of the Texas Civil Practice & Remedies Code.
