III. VENUE



IV. CAUSE OF ACTION

On or about April 14, 1998, Complainant, Richard Tomec, retained the Respondent, Peter E. Ryba, to represent him in a civil matter arising from property damage to Complainant's land. On or about May 22, 1998, Respondent filed an Original Petition on behalf of Complainant.

In December 1998, Complainant and Respondent arrived for a scheduled deposition that was immediately canceled and rescheduled for March 15, 1999, when Respondent failed to bring subpoenaed documents. When Complainant contacted Respondent by phone to verify the date of the rescheduled deposition in March, 1999, he was informed that the case had been non-suited. Respondent had non-suited Complainant's case without his knowledge or consent during a Motion for Summary Judgment hearing held on February 4, 1999. The Court granted the non-suit on February 25, 1999. Respondent failed to keep Complainant informed of the status of the case by
