III. First Cause of Action

In or around November 1993, Respondent agreed to represent Mr. Alousine Bangura ("Bangura") in a federal discrimination/wrongful termination claim against Baylor College of Medicine. After filing a petition, Respondent failed to respond to discovery requests made by opposing counsel, failed to appear at properly noticed depositions, and failed to turn over materials provided to her by Bangura.

IV.

Respondent failed to communicate with Bangura regarding the status of his claim or respond to his telephone calls and office visits requesting information.

V.

On or about September 27, 1995, Baylor College of Medicine filed a Motion to Dismiss or in the Alternative Motion to Compel Discovery and Motion for Sanctions ("Motion"). Respondent did not respond to the defendant's Motion filed on or about September 27, 1995, nor did Respondent take any steps to determine the status of the Motion.

VI.

On or about October 30, 1995, Bangura's claim against Baylor College of Medicine was dismissed for failure to prosecute, failure to comply with federal rules, and failure to cooperate in the discovery process. Respondent did not ascertain the status of Bangura's claim or advise Bangura of its dismissal. In or around May 1996, Bangura reviewed the
