

In view of Arturo A. Figueroa, Jr.'s, execution on or about January 17, 1997, of his resignation as an attorney and counselor at law, and in anticipation of the Court's acceptance of same, the Chief Disciplinary Counsel does not anticipate going forward with a compulsory disciplinary lawsuit.
