

II.



III.



direction and supervision, endorsed Atlin and Roffe's names to the checks and cashed them. Hitchery then failed to deliver the settlement funds from the checks to Atlin and Roffe.

In view of Hitchery's execution of his Motion for Resignation as an Attorney and Counselor at law on November 10, 1998, and in anticipation of the Court's acceptance of same, the Assistant Chief Disciplinary Counsel does not anticipate going forward with the pending disciplinary suit or disciplinary actions before the evidentiary and investigatory panels and intends to obtain Orders of Non-Suit in said disciplinary suit and actions before the evidentiary panel upon entry of an Order by the Supreme Court of Texas deleting Lawrence W. Hitchery from the list of persons licensed to practice law in the State of Texas.
