**ORDER GRANTING DEFENDANTS'
MOTION TO DECLARE PLAINTIFFS ALVIE AND JULIE CAMPBELL VEXATIOUS LITIGANTS
AND RENDERING FINAL JUDGMENT**

On April 14, 2014, came on to be heard the Motions to Declare Plaintiffs Alvie and Julie Campbell Vexatious Litigants (the "Motion") filed by Defendants, Wells Fargo Bank, N.A. ("Wells Fargo") and Mortgage Electronic Registration Systems, Inc. ("MERS"), Stephen C. Porter, David Seybold, Ryan Bourgeois, and Matthew Cunningham (collectively referred to as "Defendants"). After reviewing the Motions, any response thereto, the pleadings on file, and argument of counsel, the Court is of the opinion that the Motion is well taken and should be granted. It is therefore:

ORDERED, ADJUDGED AND DECREED that Defendants' Motions to Declare Plaintiffs Vexatious Litigants are hereby **GRANTED**.

IT IS FURTHER DECLARED that Alvie Campbell is a vexatious litigant.


IT IS FURTHER DECLARED that Julie Campbell is a vexatious litigant.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Alvie Campbell and Julie Campbell are prohibited forever from filing as a pro se litigant any litigation in the State of Texas relating to the property located at 250 Private Road 947, Taylor, Texas 76574, the foreclosure of said property, or any proceedings relating to the said property or ancillary matters against Wells Fargo Bank, N.A., Mortgage Electronic Registration Systems, Inc., Stephen C. Porter, David Seybold, Ryan Bourgeois, Matthew Cunningham and/or any related entities, individually or collectively, without the permission of a local administrative judge who first reviews said litigation, pursuant to section 11.102 of the Texas Civil Practice and Remedies Code, and determines that the litigation has merit and has not been filed for the purpose of harassment.

As required by Texas Civil Practice & Remedies Code section 11.104, the court clerk will provide a copy of this order to the Office of Court Administration of the Texas Judicial System.

As the Court has already granted Defendants' Motion to Dismiss and Motion for Summary Judgment, this Order disposes of all remaining claims and parties, and is final and appealable.

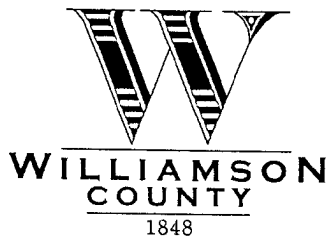
