



Transaction Volume: 7/1/2020 to 9/30/2020



- **Over 400k user accounts** created to-date
- EFM currently receiving **~38,000 envelopes per day**
- **State filing portal accounts for 77% of transactions;** remaining 23% stem from commercial EFSP submissions

New Cases Filed



- **Filing and case volume experienced a brief reduction**, due to Coronavirus pandemic
- **27.3% reduction** in new case filings in April
- **Largest Case Volume Declines:**
 - Tax Delinquency
 - Debt/Contract
 - Contract
- **Case volumes fully recovered** to pre-COVID volumes in August
 - Over 2,000 new cases per day

TX E-Filing: JP




Summary

- 134 precincts across 31 counties are live
- 16 active engagements
- 4 engagements pending


Legend

- Solution has been **utilized over 280k** times since launch

Self Help eFileTexas Update








re:SearchTX User Adoption





Summary


- In 2020, 92.50% of filings were processed in under 24 hours
 - Takes into account new criminal eFiling engagements
- 92.89% YTY Avg on filings processed in under 24 hours
 - Clerks are reviewing documents even faster!
- Statistics are consistent across the state with little-to-no variance with:
 - Population size
 - Geographic size
 - Integration method
 - Case Management System



Responses in Under 24 Hours




- Response rates are similar between courts of different sizes
- Over 90% of all filings are accepted/returned for correction within 24 hours of submission

Return for Correction Rates – Last 6 Months


Summary

- *Top 10 most populous counties continue to trend less than the state average
- Return rates decline as clerks and legal professionals become acclimated to the eFiling process
- National average is ~8%



*Tracking of top 10 counties (in population) began in September 2018

CMS Integration Status



Summary

- 82% of offices live on eFileTexas are integrated w/ their Case Management Systems (550 out of 673)
- Integration progress being made with CMS vendors:
 - 6 CMS vendors have established One-Way integration
 - 7 CMS vendors have established Two-Way integration
