Update from August 25, 2023 meeting regarding possible Latent Print/Crime Scene Model Training Academy in collaboration with Department of Public Safety and Texas Division of the International Association for Identification and discussion of possible recommendations to full Commission on rulemaking proposal related to the training programs as necessary.
