II. Meeting Minutes from the Previous meeting

Motion to approve the minutes from the November 2023 meeting by **Bob Wessels**, seconded by **John Warren**. No opposition. **Motion carried**.

III. Program Updates

Evan Acosta with Tyler Technologies provided an update on the program. Mr. Acosta spoke to the return for correction rate along with the most common case types returned. The committee asked for additional columns to indicate the percentage of cases represented by case type along with the percentage of self-represented litigants in those case types. The committee also asked for a report of return for correction reasons by clerk's office.

Mr. Acosta discussed the Guide and File program and that usage continues to climb. Justice Simmons asked that the standards subcommittee explore the reasons why additional interviews cannot be successfully integrated with eFile.

Mr. Acosta updated the group on re:Search. He indicated the volume of activity is seeing more than a 15% increase from last year. The committee asked for a report on revenue to be broken down by county.

Mr. Acosta then reviewed the program roadmap, discussing the cycle 3 release as well as the upgrade to multi-factor authentication.

IV. Subcommittee Updates

A. Standards

Bob Wessels summarized the subcommittee's work in making changes to the Technology Standards. Change included adding additional subsequent filings due to legislative fee changes. An additional return for correction reason was added to address situations where clerks must return eFilings after they had been accepted due to a system error. A section was added to describe the security constructs on cases and documents. Definitions and permissions were altered to support the inclusion of criminal cases in re:Search. A new section on role 5 (Public) permissions was added to include criminal case information, but no documents.

Motion to approve version 8 of the Technology Standards by **Bob Wessels**, seconded by **Dan Hinde**. No opposition. **Motion carried**.

B. Orders on re:SearchTX

Todd Smith gave an update on the subcommittee's work. Mr. Smith discussed the three recommendations that the subcommittee crafted.

The committee discussed the recommendations individually and discussed the timeline for implementation.

Justice Boyd made several recommendations to further clarify the recommendations prior to adopting them and sending to the Supreme Court for consideration.

Justice Simmons requested that the subcommittee chairs confer and implement the changes suggested by Justice Boyd. The subcommittee chairs agreed and will circulate the changes to the committee and request they be adopted by electronic vote once complete.
