To effectuate this Order in an administratively efficient manner:

(A) cases transferred by this Order are removed from the active dockets of the Courts of Appeals for the First through Fourteenth Court of Appeals

Districts effective August 31, 2024, but administrative steps to effectuate the transfers may begin on the date of this Order; and

(B) cases transferred by this Order are entered onto the docket of the Court of Appeals for the Fifteenth Court of Appeals District effective September 1, 2024.

X.

This Order is not a determination by this Court of any legal issues regarding the jurisdiction of the Court of Appeals for the Fifteenth Court of Appeals District.
