The meeting of the Judicial Branch Certification Commission (Commission) was called to order by Judge Sid Harle, Chair, at 10:00 a.m. Members in attendance were Judge Sid Harle; Judge William Sowder; Judge Victor Villarreal; Judge Polly Spencer; Judge Glen Harrison; Velma Arellano; Ann Murray Moore; Don Ford; and Mark Blenden.

Agenda Item III. Opening Remarks

Judge Harle welcomed everyone to the meeting and thanked Judge Sowder for chairing the previous Commission meeting. Judge Harle welcomed Ron Morgan, new Commission Director and thanked staff for their hard work getting the meeting ready.

The Commission Director thanked the Commission for their kind words and introduced himself to the group. He thanked the members for their service and thanked the staff for their hard work. The Commission Director shared there are 141 pending investigations, 7200 active licensees, which is broken down as follows: 2300 court reporters, 253 court reporting firms, 373 guardians, 36 guardianship programs, 3700 process servers, and 486 court interpreters. 109 of our licensees' certifications and registrations are pending renewal and over 1000 applications for new licenses, certifications and registrations are pending in various stages.

The Commission Director outlined specific goals for each department. For compliance, the focus is on maximizing efficiencies, improving processes, and ensuring optimal resource allocation. Regarding licensing, the priority is to identify actionable solutions to address shortages, while also engaging with stakeholders from various associations to explore how we can best support them.
