"We, the jury, find the defendant **NOT GUILTY** of the offense of CT 1: CAPITAL MURDER."

It is therefore ORDERED, ADJUDGED and DECREED by the Court that the Defendant is not guilty of Ct 1: Capital Murder, that he be immediately discharged from all further liability upon the charge of CT 1, for which he has been tried and that he go hence without payment of costs.
