ORDER ON DEFENDANT'S MOTION TO DECLARE PLAINTIFF A VEXATIOUS LITIGANT

On this day, came on to be heard Defendant Methodist Hospitals of Dallas' (hereinafter "Defendant") Motion to Declare Plaintiff, Teel Styles, a Vexatious Litigant. After proper notice and hearing the arguments of the Parties and counsel, reviewing the pleadings, and considering the evidence, the Court is of the opinion that that Motion is well taken and should be **GRANTED**.

IT IS THEREFORE ORDERED, ADJUDGED, and DECREED as follows:

Plaintiff, Teel Styles, must furnish security for the benefit of Defendant, Methodist Hospitals of Dallas, by posting security with the court clerk in the amount of \$_1,500.00\$ by __August 29 ____, 2025. This Court states that the security is an undertaking by the Plaintiff, Teel Styles, to assure payment to Defendant for it's reasonable expenses incurred in or in connection with a litigation commenced, caused to be commenced, maintained, or caused to be maintained by the Plaintiff, Teel Styles, including costs and attorney's fees, including any anticipated appeal by the Plaintiff, should the case be dismissed on the merits. *See*, TEX. CIV. PRAC. & REM. CODE §§ 11.055(c) and 11.057.

If Plaintiff does not furnish the required security within the time limit set by this Order above, the Court will dismiss this suit with prejudice against the Plaintiff, Teel Styles. *See*, TEX. CIV. PRAC. & REM. CODE § 11.056.

This suit will remain in abatement until ten days after Plaintiff, Teel Styles, complies with this order and Defendant is provided written notice that she has furnished the required security, or until it is dismissed by further order of this Court. *See*, TEX. CIV. PRAC. & REM. CODE §§ 11.052.

IT ITS FURTHER ORDERED, the Plaintiff, Teel Styles, is hereby declared a vexatious litigant under Tex. Civ. Prac. & Rem. Code § 11.101(a) as she meets the necessary requirements under § 11.054. Therefore, by the Order of this Court, Teel Styles, is hereby prohibited from filing, pro se, any new litigation in any court within the State of Texas without the consent and permission of the appropriate local administrative judge described by Section 11.102(a) to file the potential new litigation. *See*, Tex. Civ. Prac. & Rem. Code §§ 11.101(a)

Let it be known, if Plaintiff, Teel Styles, disobeys this Order, she will be subject to contempt of court. See, TEX. CIV. PRAC. & REM. CODE §§ 11.101(b).

IT IS FURTHER ORDERED, pursuant to TEX. CIV. PRAC. & REM. CODE § 11.104, the clerk of the court will provide a copy of this Order to the Office of Court Administration of the Texas Judicial System.
