ORDER

Pending before the Court is the Motion for Sanctions and for Plaintiff to be Declared a Vexatious Litigant pursuant to Rule 13 of the Texas Rules of Civil Procedure and Chapter 10 & 11 of the Texas Civil Practice and Remedies Code filed by Defendants Schlumberger Technology Corporation (Index. # 18) , Alexander C. Landin, MaryJo L. Roberts, and Eric R. Miller. After reviewing the Motion, the live pleadings, records, and applicable law, and conducting a hearing on the matter:

IT IS HEREBY ORDERED that the Motion is **GRANTED**, and that Plaintiff Gyanendra K. Patra is hereby declared a vexatious litigant and is prohibited from filing a new *pro se* litigation in a Texas state court unless he first obtains permission from a local administrative judge.

IT IS FURTHER ORDERED that Plaintiff Gyanendra K. Patra is hereby prohibited from filing a new *pro se* litigation in a Texas state court unless he first obtains permission from a local administrative judge against the following individuals and entities: (a) Schlumberger Technologies Corporation or any parents, subsidiaries or affiliated entities, (b) MaryJo L. Roberts, (c) Alexander C. Landin, (d) Eric R. Miller, (e) any other attorneys or employees of The

Kullman Firm APLC, and (f) Christopher L. Tritico and any other attorneys or employees of Tritico Rainey, ASSN.

As required by Texas Civil Practice & Remedies Code Section 11.104, the Clerk of Court will provide a copy of this Order to the Office of Court Administrator of the Texas Judicial System.

IT IS HEREBY FURTHER ORDERED that Plaintiff Gyanendra K. Patra is hereby ordered to pay unto Defendants the sum of \$ 100.00 as sanctions.
