ORDER GRANTING DEFENDANTS' MOTION TO DECLARE TALEK SHERMAN A VEXATIOUS LITIGANT AND FOR ORDER REQUIRING SECURITY

On this day came on to be considered Defendants AFH-Hillcrest LLC, incorrectly names as Hillcrest Apartments¹ and Jennifer Prieto, incorrectly named as Jennifer Erieto² (collectively, "*Defendants*") Motion to Declare Plaintiff Talek Sherman a Vexatious Litigant and to require the posting of security pursuant to Chapter 11 of the Texas Civil Practice and Remedies Code. After reviewing the motion, the Court finds that the Motion should be GRANTED.

IT IS THEREFORE ORDERED that Talek Sherman is hereby declared to be a VEXATIOUS LITIGANT as that term is defined in Chapter 11 of Title 2 of the Texas Civil Practices and Remedies Code.

It is further **ORDERED**, **ADJUDGED** and **DECREED**, in accordance with the provision of the Tex.Civ.Prac & Rem. Code § 11.02, that Talek Sherman is hereby **PROHIBITED** from filing, any civil action in Texas State Cin propria persona, a new litigation in a court in this State without first either (i) obtaining the permission of the local administrative judge of the court in
