These reports must be emailed to bail@txcourts.gov with the subject line in the following format: Charitable Bail Organization [Month Name] Report. In addition, organizations must follow any local jurisdictional procedures required to notify the Sheriff's office.

A charitable bail organization may not pay a bail bond for a defendant at any time if the organization is considered to be out of compliance with the reporting requirements of this article.

A charitable bail organization may not accept a premium or compensation for paying a bail bond for a defendant.

By signing below, I acknowledge that I certify the information provided above is true and correct and the organization named in this application is current on all filings required by the Internal Revenue Code.

If there is reason to believe the charitable organization posting bail may have paid one or more bonds in violation of the notated article, the Office of Court Administration shall report that information to the sheriff of the county in which the suspected violation occurred; at which point the sheriff may suspend the organizations ability to pay bonds within the jurisdiction for a period of time not to exceed one year.
