## ORDER GRANTING DEFENDANT'S MOTION FOR ORDER DETERMINING PLAINTIFF A VEXATIOUS LITIGANT

On October 16, 2025, the Court called Defendant's Motion for Order Determining Plaintiff a Vexatious Litigant in the above-captioned cause. The Court directed the movant to submit all exhibits to the respondent Jacob Barreras, and recessed the hearing to October 21, 2025, to accommodate his ability to review all proposed exhibits and evidence in the hearing. Today, the hearing was reconvened, evidence and argument was taken, and after due consideration, the Court is of the opinion that the motion should be granted. The Court determines that Jacob Barreras is a vexatious litigant pursuant to Tex. Civ. Prac. & Rem. Code 11.054.

Accordingly, IT IS ORDERED that Defendant's Motion for Order Determining Plaintiff a Vexatious Litigant is GRANTED.

IT IS FURTHER ORDERED that Plaintiff must furnish security for the benefit of Defendant Digitech Computer LLC in the amount of \$15,000, to assure payment to the moving defendant of the moving defendant's reasonable expenses incurred in or in connection with a litigation commenced, caused to be commenced, maintained, or caused to be maintained by the plaintiff, including costs and attorney's fees.

IT IS FURTHER ORDERED that, by no later than October 31, 2025, Plaintiff shall, without objection, fully and completely comply with this Order requiring Plaintiff to furnish the security.

IT IS FURTHER ORDERED that, pursuant to Tex. Civ. Prac. & Rem. Code § 11.101, Plaintiff Barreras is prohibited from filing, pro se, a new litigation in any court in Texas without first obtaining the permission from the appropriate local administrative judge.

The District Clerk is directed to provide the Office of Court Administration of the Texas Judicial System a copy of this Order not later than the 30th day after today's date.
