## FY 2025 Performance Measures Report Summary Statistics



OCA processed 1,278 reports submitted by county and district clerk offices throughout Texas. Overall, 99% of District Courts, 95% of Statutory County Courts, and 96% of Constitutional County Courts submitted performance measures reports. Ninety-two percent (92%) of district and county courts had a clearance rate above 90%.

# **The First Annual Texas Business Court Report & 15<sup>th</sup> Court of Appeals Report**

## **Business Court Report**

OCA has published the first annual Texas Business Court report for FY 2025. Texas Business Court became operational on September 1, 2024, and within the fiscal year, a total of 185 cases were filed, averaging around 15 cases per month. Out of the 185 cases filed, 57% were original petitions. Ten (10) Business Court divisions are currently active. See [The Business Court of Texas Annual Report FY 2025](#).

## **15th Court of Appeals Report**

In operation since September 1, 2024, the 15th Court of Appeals (COA) is the newest appellate court in Texas. The 15th COA, unlike the other appellate courts, was authorized to hear cases across the state. The 15th COA also has exclusive appellate jurisdiction to appeals from an order or judgment from the Texas Business Court. See [Fifteenth Court of Appeals Report](#).





## Texas Fun Facts



Edith Eunice Therrel Wilmans (1882-1966) was the first woman elected to the Texas Legislature in 1922, representing Dallas County, District 50. While serving, she endorsed legislation for child support and childcare and for the establishment of the Dallas County District Court of Domestic Relations. She served only one term in the Legislature and ran unsuccessfully for governor in 1924 and 1926. In 1925, Governor Pat M. Neff appointed her to the all-woman Texas Supreme Court, but she was disqualified from serving because she lacked just a few months of the required seven years' experience in the practice of law. Edith Wilmans died in Dallas on March 21, 1966.
